## LOCAL GOVERNMENT, ENGLAND

### The Ellesmere Port and Neston (Parish) Order 2007

Made - - - - 19<sup>th</sup> December 2007

*Coming into force in accordance with article 1(2)*

The Secretary of State, in exercise of the powers conferred by sections 14 and 23 of the Local Government and Rating Act 1997(a), makes the following Order which gives effect (without modification) to petitions under section 11 of that Act.

#### Citation, commencement and interpretation

1. — (1) This Order may be cited as the Ellesmere Port and Neston (Parish) Order 2007.

(2) It shall come into force —

(a) for the purposes of this article and proceedings preliminary or relating to elections of parish councillors to be held on the ordinary day of elections in 2008, on the day after that on which it is made;

(b) for all other purposes, on 1st April 2008.

(3) In this Order—

“the new parish” means the parish constituted by article 2; and

“the map” means the map prepared by the Department for Communities and Local Government, marked “Map referred to in the Ellesmere Port and Neston (Parish) Order 2007” and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

### **Constitution of new parish of Neston**

2.—A new parish, comprising the area outlined in blue on the map, shall be constituted within the borough of Ellesmere Port and Neston.

(2) The name of the new parish shall be Neston.

### **Directions to establish parish councils**

3. The Ellesmere Port and Neston Borough Council is hereby directed to establish a parish council for the new parish.


### **Transitional Provisions**

4 —(1) Until the councillors elected to the council of the new parish of Neston at the elections to be held on the ordinary day of elections in 2008 come into office, the new parish shall be represented by those persons who, immediately before 1<sup>st</sup> April 2008, are the elected councillors for the district wards of Burton and Ness, Riverside, Little Neston, Neston and Parkgate.

### **Order Date**

5. 1st April 2008 is the order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order gives effect (without modification) to a petition sent to the Secretary of State for the creation as a parish of an area within the borough of Ellesmere Port and Neston and for the establishment of a parish council for that area.

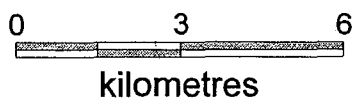
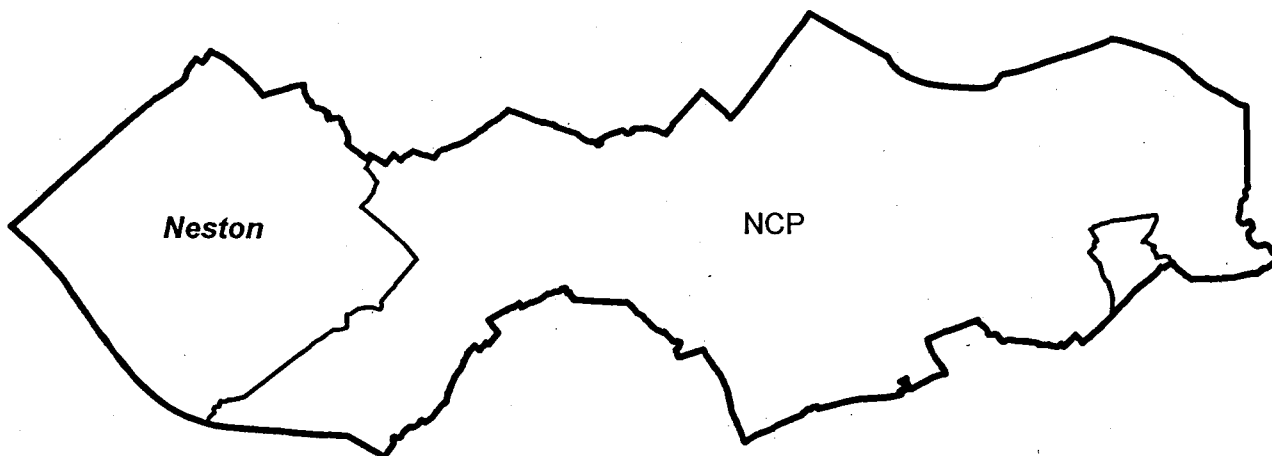
Article 2 creates a new parish to be called Neston.

Article 3 directs the Ellesmere Port and Neston Borough Council to establish a parish council for the new parish.

Article 4 provides for the parish of Neston to be represented by the district councillors elected for the district wards of Burton and Ness, Riverside, Little Neston, Neston and Parkgate until councillors for the new parish, to be elected on the ordinary day of election in 2008, come into office.

Article 5 specifies 1<sup>st</sup> April 2008 as the Order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make provision of general application in relation to orders such as this Order.
