Thank you for your email of 21 October, which we received on 22 October 2014, requesting information under the Freedom of Information Act 2000.

You have requested:

“...letters/documents referring to Leigh that were used in the decision to remove Leigh from the Yetminster and Cam Vale Ward to the Frome Valley Ward. These are likely to have arisen when deciding to deal with the response to the Chetnole submission, although there may be other copies of minutes etc.”

Other than previously published information, I can confirm that the Commission does not hold information relevant to your request.

After a thorough search of the West Dorset electronic folders and paper files, the only documents found that mention Leigh are already published on the Commission's website.
