### **ELECTORAL REVIEW OF FENLAND: DRAFT RECOMMENDATIONS**

Having considered the representations received during the initial stages of the review, the Commission today publishes its draft recommendations on the future electoral arrangements for Fenland District Council. We have also arranged with your officers for hard copies of the report to be sent to the Council.

An interactive map of the Commission's draft recommendations for Fenland, electoral figures and guidance on how to propose new wards are available in the consultation area [consultation.lgbce.org.uk](http://consultation.lgbce.org.uk). Here you can view the existing ward boundaries against the draft recommendations and have your say. Technical guidance can be found on the *Policy and publications* page of our website.

The Commission is now undertaking a period of consultation on its draft recommendations and is seeking the views of local people. It would be helpful if your Council could further publicise the Commission's draft recommendations by displaying the posters sent to your Council and taking such other steps as it considers appropriate to bring the review to the attention of the public and other interested parties.

We will send copies of all representations to you at the end of this consultation stage. I would be grateful if you would kindly make them available for public inspection on receipt. Copies of representations will also be posted on the Commission's website, at [www.lgbce.org.uk](http://www.lgbce.org.uk) and made available for inspection at the Commission's offices, by appointment.

Representations must be submitted to the Commission by **7 January 2013**. I should stress that the Commission has not finalised its conclusions and, in light of further evidence, may put forward final recommendations which differ from those set out in the draft recommendations. We therefore encourage all those who have a view to write to the Commission, whether they agree with its draft recommendations or not. It is very important that those who oppose the draft recommendations should suggest alternatives which are supported by evidence.

All representations received during the consultation period will be taken into account and the Commission will then consider whether or not to amend its draft recommendations. When the final recommendations are published, copies will again be sent to your Council and the other stakeholders detailed above.
