**The Hinckley and Bosworth (Parish Electoral Arrangements)  
Order 2007**

*Made* - - - - - *25th January 2007*

*Coming into force in accordance with article 1(2)*

Hinckley and Bosworth Borough Council, under section 12(a) of the Local Government and Rating Act 1997(b) (“the 1997 Act”), have sent to the Electoral Commission(c) proposals dated October 2006 for electoral arrangements in the proposed parish of Barwell(d) in the borough of Hinckley and Bosworth:

The Electoral Commission have decided to give effect to those proposals:

Accordingly, the Electoral Commission, in exercise of the powers conferred by sections 14(e) and 23(f) of the 1997 Act, make the following Order:

**Citation and commencement**

1.—(1) This Order may be cited as the Hinckley and Bosworth (Parish Electoral Arrangements) Order 2007.

(2) This Order comes into force—

- (a) for the purpose of proceedings preliminary or relating to the elections of parish councillors for the parish of Barwell, to be held on the ordinary day of election of councillors in 2007, on the day after that on which it is made;
- (b) for all other purposes, on the ordinary day of election of councillors in 2007.

**Interpretation**

2. In this Order—

“map” means the map marked “Map referred to in the Hinckley and Bosworth (Parish Electoral Arrangements) Order 2007”, of which prints are available for inspection at the principal office of the Electoral Commission;

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983(a); and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8(b) of the Representation of the People Act 1983.

### **Elections for the parish of Barwell**

3. Elections of all parish councillors for the parish of Barwell shall be held simultaneously on the ordinary day of election of councillors in 2007(c).

### **Wards of the parish of Barwell**

4.—(1) The parish of Barwell shall be divided into three wards which shall be named Charnwood, Redhall and St Mary’s.

(2) Each ward shall comprise the area designated on the map by reference to the name of the ward and demarcated by orange lines.

(3) The number of councillors to be elected for St Mary’s ward shall be six, for Charnwood ward shall be four, and for Redhall ward shall be two.

### **Map**

5. Hinckley and Bosworth Borough Council shall make a print of the map available for inspection at its offices by any member of the public at any reasonable time.

### **Electoral register**

6. The registration officer for the borough of Hinckley and Bosworth shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order gives effect to proposals sent to the Electoral Commission for electoral arrangements for the new parish of Barwell, created within the borough of Hinckley and Bosworth by the Hinckley and Bosworth (Parish) Order 2006.

The new electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2007.

Article 3 provides for parish elections in the parish of Barwell in 2007, and then to continue according to the established system of parish elections every four years.

Article 4 establishes the names and areas of the wards of that parish and the numbers of councillors for each ward.

Article 6 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.
