PROPOSALS FOR FUTURE ELECTORAL ARRANGEMENTS FOR THE LONDON
BOROUGH OF HOUNSLOW

1. We, the Local Government Boundary Commission for England, having carried out a review of the electoral arrangements for the London borough of Hounslow in accordance with Section 50(3) of the Local Government Act, 1972, present our proposals for the future electoral arrangements for that London borough.
2. In accordance with the procedure laid down in Section 60(1) and (2) of the 1972 Act, notice was given on 10 June 1975 that we were to undertake this review. This was incorporated in a consultation letter addressed to the Hounslow Borough Council, copies of which were circulated to the Greater London Council, the London Boroughs Association, the Association of Metropolitan Authorities, the Members of Parliament for the constituencies concerned, the headquarters of the main political parties and the Greater London Regional Council of the Labour Party. Copies were also sent to the editors of local newspapers and of the local government press. Notices inserted in the local press announced the start of the review and invited comments from members of the public and from any interested bodies.
3. The Hounslow Borough Council were invited to prepare a draft scheme of representation for our consideration. When doing so, they were asked to observe the rules laid down in Schedule 11 to the Local Government Act 1972 and the guidelines which we set out in our letter of 10 June 1975 about the proposed size of the council and the proposed number of councillors for each ward. They were also asked to take into account any views expressed to them following their consultation with local interests. We therefore asked that they should publish details of their provisional proposals about six weeks before they submitted their draft scheme to us, thus allowing an opportunity for local comment.

4. On 10 March 1976 the Hounslow Borough Council presented their draft scheme of representation. The Council proposed to divide the area of the borough into 21 wards, each returning 2 or 3 members to form a council of 60.

5. We received one suggestion that there should be a larger council and various comments from political parties and local associations offering alternative arrangements for the Chiswick area of the Borough. These sought to retain a 3-member Chiswick Homefields ward instead of the 2-member Chiswick Homefields ward proposed by the Council, and there were proposals to redraw the boundaries in this area to create a larger Chiswick Homefields ward which could be represented by 3 councillors and a smaller Gunnersbury ward which could be represented by 2 councillors.

6. We considered the draft scheme submitted by the Council. We noted that the size of council proposed was in accordance with the guidelines set out in our letter of 10 June 1975. We considered the warding arrangements proposed by the Council and noted that they complied with the rules in Schedule 11 to the Local Government Act 1972 and with our own guidelines. We studied the alternative proposals put forward for the Chiswick area, but we preferred those proposed by the Council. We therefore adopted the Council's draft scheme without modification and formulated our draft proposals accordingly.

7. On 15 October 1976 we issued our draft proposals and these were sent to all who had received our consultation letter and to those who had commented on the draft scheme. The Council were asked to make our draft proposals and the accompanying map which defined the ward boundaries, available for inspection at their main offices. Representations on our draft proposals were invited from those to whom they were circulated and, by public notices, from members of the public and interested bodies. We asked for comments to reach us by 9 December 1976.

8. We received comments supporting our draft proposals, but two local associations expressed continued dissatisfaction with the proposed arrangements for the Chiswick area and would have preferred alternative arrangements which we had already considered. It was said that greater equality of representation could be achieved in this area. We examined again the current electorates and the future estimated electorates of the wards we had proposed and noted that, looking ahead for five years as we are required to do, the standard of representation would be satisfactory. We therefore decided to confirm our draft proposals as our final proposals.

9. Details of these final proposals are set out in Schedule 1 to this report and on the attached map. Schedule 1 gives the names of the wards and the number of councillors to be returned by each. The boundaries of the new wards are defined on the map.

PUBLICATION

10. In accordance with section 60(5)(b) of the Local Government Act 1972 a copy of this report and a copy of the map are being sent to Hounslow Borough Council and will be made available for public inspection at the Council's main offices. Copies of this report (without maps) are being sent to those who received the consultation letter and to those who made comments. A detailed description of the boundaries of the proposed wards as defined on the map is set out in Schedule 2 to this report.

DESCRIPTION OF PROPOSED WARD BOUNDARIES

NOTE: Where the boundary is described as following a road, railway, river, canal or similar feature it should be deemed to follow the centre line of the feature unless otherwise stated.

HESTON WEST WARD

Commencing at the point where the M4 motorway meets the western boundary of the Borough, thence generally northwards along said boundary to the northern boundary of the Borough, thence generally southeastwards along said Borough boundary to the eastern boundary of Barnes Farm, thence generally southwards along said boundary to North Hyde Lane, thence southeastwards and generally southwards along said lane to Vicarage Farm Road, thence southwestwards along said road to Cranford Lane, thence westwards along said lane to Springwell Road, thence southwestwards along said road to Great West Road, thence southwestwards along said road to Bath Road, thence northwestwards along said road to the road known as The Parkway, thence generally northwestwards along said road to National Grid reference TQ 1040477677, thence westwards in a straight line to the western boundary of the Borough, thence northwards along said boundary to the point of commencement.

HESTON EAST WARD

Commencing at the point where the M4 motorway meets the eastern boundary of Heston West Ward, thence northwards, northwestwards and generally northwards along said boundary to the northern boundary of the Borough, thence north-eastwards, southeastwards and generally eastwards along said boundary to Osterley Lane, thence southeastwards in a straight line to the northeastern corner of the estate between Farraro Close and the Heston Schools, (east of Heston Road) at National Grid reference TQ 1353677971, thence generally southwestwards along the eastern boundary of said estate and in prolongation thereof to the northern boundary of the Heston Schools, thence eastwards along said boundary and southwards along the eastern boundary of said schools to Heston Road, thence generally southeastwards along said road to the Great

West Road, thence southwestwards along said road to Upper Sutton Lane, thence northwards and northwestwards along said lane and continuing northeastwards along Church Road to Heston Road, thence northwestwards along said road to New Heston Road, thence northwestwards along said road to Walnut Tree Road, thence generally northwestwards along said road to the footpath that leads from Walnut Tree Road to Fern Lane, thence generally northwestwards along said footpath to the M4 motorway, thence southwestwards along said motorway to the point of commencement.

HESTON CENTRAL WARD

Commencing at the point where the Great West Road meets the southeastern boundary of Heston West Ward, thence generally northeastwards, southeastwards and northwards along the southeastern and eastern boundaries of said ward to the southwestern boundary of Heston East Ward, thence northeastwards, and generally southeastwards along said boundary to Great West Road, thence southwestwards along said road to the point of commencement.

SPRING GROVE WARD

Commencing at the point where the eastern boundary of Heston East Ward meets the northern boundary of the Borough, thence northeastwards and southeastwards along said Borough boundary to Windmill Lane, thence southwards along said lane to Jersey Road, thence westwards and southwards along said road to Wood Lane, thence southeastwards along said lane crossing Great West Road to the Syon Lane to Hounslow railway, thence southwestwards along said railway to St John's Road, thence southeastwards along said road to Woodlands

Road, thence southwards along said road to the road known as Riverside Walk, thence southwestwards along said road to Worton Road, thence westwards along said road to Bridge Road, thence northwestwards along said road, crossing London Road, to and northwestwards along the footpath that leads from London Road to Worton Way, to Worton Way, thence northwestwards along said way to Spring Grove Road, thence westwards along said road to Gresham Road, thence northwestwards along said road to the Great West Road, thence southwestwards along said road to the eastern boundary of Heston East Ward, thence generally northwards along said boundary to the point of commencement.

ISLEWORTH NORTH WARD

Commencing at the point where the eastern boundary of Spring Grove Ward meets the northern boundary of the Borough, thence eastwards and southwards along said Borough boundary to the point where the Boston Manor to Osterley railway crosses the Grand Union Canal, thence continuing generally southeastwards along said canal to its divergence from the River Brent at the northwestern corner of the British Waterways Brentford Depot, thence southeastwards and southwestwards along the River Brent to its junction with the Grand Union Canal at Brentford Bridge, thence generally southeastwards and northeastwards along said canal to a point opposite the northeastern boundary of Syon Park, thence eastwards to and southeastwards along said boundary and in prolongation thereof to the southeastern boundary of the Borough, being the River Thames, thence southwestwards along said boundary

to a point being the prolongation eastwards of the unnamed access road to the south of Lion Wharf, thence westwards along said prolongation and said unnamed road, crossing Richmond Road to South Street, thence westwards along said street to Twickenham Road, thence northwards along said road to St John's Road, thence northwestwards along said road to the eastern boundary of Spring Grove Ward, thence generally northwards along said boundary to the point of commencement.

BRENTFORD CLIFDEN WARD

Commencing at the point where the northeastern boundary of Isleworth North Ward meets the northern boundary of the Borough, thence generally eastwards along said Borough boundary to Ealing Road, thence southeastwards along said road to High Street, thence southwestwards along said street to Smith Hill, thence southeastwards along said hill to the high water mark, thence due eastwards to the southeastern boundary of the Borough, thence southwestwards along said boundary to the northeastern boundary of Isleworth North Ward, thence generally northwestwards along said boundary to the point of commencement.

GUNNERSBURY WARD

Commencing at the point where the eastern boundary of Brentford Clifden Ward meets the northern boundary of the Borough, thence generally northeastwards and southeastwards along said Borough boundary to the South Acton to Kew Gardens railway, thence southwestwards along said railway to

the southeastern boundary of the Borough, thence northwestwards and southwestwards along said boundary to the eastern boundary of Brentford Clifden Ward, thence northwestwards along said boundary to the point of commencement.

TURNHAM GREEN WARD

Commencing at the point where the eastern boundary of Gunnersbury Ward meets the northern boundary of the Borough, thence eastwards along said Borough boundary to a point opposite the access way to the rear of the properties on the north side of Thornton Avenue, thence eastwards to and along said access way to a point opposite the western boundary of number 98 Thornton Avenue, thence southwards to and along said boundary, crossing said avenue and continuing southwards along the rear boundaries of Nos 90-58 Turnham Green Terrace and in prolongation thereof to the rear boundaries of Nos 56-50 Turnham Green Terrace, thence generally southwards along said boundaries to the northern boundary of No 48 in said terrace, thence eastwards along said boundary to the rear boundary of said property, thence southwards along said boundary, the rear boundaries of Nos 46-40 Turnham Green Terrace and the rear boundaries of Chiswick Commercial Club and the property known as Gable House and in prolongation thereof to the rear boundaries of Nos 12-2 Turnham Green Terrace, thence southwards along said boundaries to the southern boundary of No 2 in said terrace, thence westwards along said boundary to Turnham Green Terrace, thence southwards along said terrace to Chiswick High Road, thence eastwards along said road to Brackley Road, thence southwards along said road to a point opposite the northern boundary of No 1 in said road, thence eastwards to and along said boundary to the rear boundary of said property, thence southeastwards along said boundary and the rear boundaries of Nos 3-47 Brackley Road, to the southern boundary of the last mentioned property, thence southwestwards along said boundary to Brackley Terrace, thence southeastwards along said terrace to Manor Alley, thence southwestwards along said Alley to Devonshire Road, thence southeastwards along said road to the roundabout junction of said road, Great West Road,

Great Chertsey Road and Church Lane, thence southwestwards along the north-western carriageway of said roundabout to Great West Road, thence westwards along said road to the eastern boundary of Gunnersbury Ward, thence north-eastwards along said boundary to the point of commencement.

CHISWICK HOMEFIELDS WARD

Commencing at the point where the eastern boundary of Turnham Green Ward meets the northern boundary of the Borough, thence northeastwards and generally southeastwards along said Borough boundary to the eastern boundary of the Borough, thence southwards along said boundary to the southeastern boundary of the Borough being the River Thames, thence southwestwards along said boundary to a point due southeastwards of the southernmost corner of the Transport and Packing Depot centred at NG ref TQ 2153777618, thence due northwestwards to and northwestwards along the southwestern boundary of said depot to the unnamed road continuing northeastwards from Pumping Station Road, thence southwestwards along said road to a point due southeastwards of the easternmost corner of St Joseph's Hospital, thence due northwestwards to and northwestwards along the northeastern boundary of said Hospital and westwards along to northern boundary of said hospital to Great Chertsey Road, (Burlington Lane), thence northeastwards along said road to the roundabout junction of said road, Great West Road, Devonshire Road and Church Street, thence northwestwards along the southwestern carriageway of said roundabout to the eastern boundary of Turnham Green Ward, thence generally northwards along said boundary to the point of commencement.

CHISWICK RIVERSIDE WARD

Commencing at the point where the southeastern boundary of the Borough, being the River Thames meets the eastern boundary of Gunnersbury Ward, thence northwards along said ward boundary to the southern boundary of

Turnham Green Ward, thence eastwards along said boundary to the western boundary of Chiswick Homefields Ward, thence generally southwestwards and southeastwards along said boundary to the southeastern boundary of the Borough, being the River Thames, thence generally southwestwards and northwards along said boundary to the point of commencement.

ISLEWORTH SOUTH WARD

Commencing at the point where the southern boundary of Isleworth North Ward meets the southeastern boundary of the Borough, being the River Thames, thence generally southwards and westwards along said Borough boundary to the Duke of Northumberland's River, thence northeastwards along said river to the road known as Whitton Dene, thence eastwards along said road to the access road to Mogden Main Drainage Works, thence northwards, westwards and northwards along said access road to Oak Lane, thence due west to the Duke of Northumberland's River, thence northwards along said river to Worton Road, thence westwards along said road to the southeastern boundary of Spring Grove Ward, thence northeastwards along said boundary to the southern boundary of Isleworth North Ward, thence generally southeastwards along said boundary to the point of commencement.

HOUNSLOW SOUTH WARD

Commencing at the point where the western boundary of Isleworth South Ward meets the southeastern boundary of the Borough, thence generally westwards along said Borough boundary to Hanworth Road, thence northeastwards along said road to Cross Lances Road, thence southeastwards along said road to Heath Road, thence eastwards along said road to the Hounslow to Isleworth railway, thence northeastwards along said railway to the southwestern boundary of Spring Grove Ward, thence southeastwards along said boundary to the western boundary of Isleworth South Ward, thence generally southwards along said boundary to the point of commencement.

HOUNSLOW CENTRAL WARD

Commencing at the point where the southwestern boundary of Spring Grove Ward meets the northern boundary of Hounslow South Ward, thence southwestwards along said northern boundary to Hanworth Road, thence northeastwards along said road to Bell Road, thence northwestwards along said road to Lampton Road, thence generally northwards along said road to the southwestern boundary of Spring Grove Ward, thence eastwards and southeastwards along said ward boundary to the point of commencement.

HOUNSLOW WEST WARD

Commencing at the point where the western boundary of Hounslow South Ward meets the southeastern boundary of the Borough, thence generally southwestwards along said Borough boundary to the River Crane, thence generally northwestwards along said river to Staines Road, thence northeastwards along said road to Wellington Road North, thence northwards along said road to Sutton Lane, thence northeastwards along said lane to the southern boundary of Heston Central Ward, thence northeastwards along said boundary and the southern boundary of Heston East Ward to the western boundary of Hounslow Central Ward, thence generally southwards along said boundary to the western boundary of Hounslow South Ward, thence southwestwards along said boundary to the point of commencement.

HOUNSLOW HEATH WARD

Commencing at the point where the southern boundary of Heston Central Ward meets the northwestern boundary of Hounslow West Ward, thence southwards and southwestwards along said northwestern boundary to the access road on the western side of the Works west of Islay Gardens, thence northwestwards along said access road to the southern boundary of the Allotment Gardens, thence southwestwards, northwestwards and northeastwards along the southern, western and northern boundaries of said Allotment Gardens to the access way to the rear of the properties on the eastern side of Beavers Crescent,

thence northwestwards along said access way to Beavers Lane, thence westwards along said lane to a point opposite the eastern boundary of No 5 Beavers Lane, thence northeastwards to and along said boundary and continuing northwards to and along the rear boundaries of Nos 143-79 Basildene Road to the northern boundary of No 79 in said road, thence northwestwards along said boundary, crossing Basildene Road and continuing northwestwards along the rear boundaries of Nos 65-91 Clifford Road, to the rear boundary of No 28 Wilton Road, thence northwards along said boundary, the rear boundaries of Nos 26-2 Wilton Road to the western boundary of No 35 Vincent Road, thence northwards along said boundary and the western end of said road to the western boundary of No 42 Vincent Road, thence northwards along said boundary to the rear boundary of No 2 Lela Avenue, thence westwards, northwards and northeastwards along the rear boundaries of Nos 2-100 Lela Avenue to a point being the prolongation southwards of the eastern boundary of numbers 1 and 2 Lancaster Place, thence northwards along said prolongation and said boundary to the southern boundary of Heston West Ward, thence northeastwards along said boundary and the southern boundary of Heston Central Ward to the point of commencement.

CRANFORD WARD

Commencing at the point where the northwestern boundary of the Borough meets the southern boundary of Heston North Ward, thence eastwards along said boundary to the western boundary of Heston West Ward, thence generally southeastwards along said boundary to the western boundary of Hounslow Heath Ward, thence generally southwards along said boundary to the northwestern boundary of Hounslow West Ward, thence southwestwards along said boundary to the River Crane, thence generally northwestwards along said river to the northwestern boundary of the Borough, thence generally northeastwards along said boundary to the point of commencement.

EAST BEDFONT WARD

Commencing at the point where the northwestern boundary of the Borough meets the western boundary of Cranford Ward, thence generally southeastwards along said Ward boundary to Staines Road, thence southwestwards along said road to Bedfont Lane, thence southeastwards along said lane to a point opposite the northwestern boundary of the Nurseries, thence southwestwards to and along said boundary and continuing southwestwards in a straight line to the northernmost corner of No 19 Oak Way, thence southeastwards and generally southwards along the rear boundary of said property and the rear boundaries of Nos 21-75 Oak Way and in prolongation thereof to the path that leads from Southville Road to Guildford Avenue, thence southeastwards along said path to the Feltham to Ashford railway, thence southwestwards along said railway to a point opposite the western boundary of Her Majesty's Borstal Institution, thence southwards to and generally southwards along said boundary to the rear boundary of No 22 Portland Crescent, thence westwards along said boundary and the rear boundary of No 24 Portland Crescent to Challenge Road, thence southwards along said road to the southwestern boundary of the Borough, thence generally northwestwards along said boundary and generally northeastwards along the northwestern boundary of the Borough to the point of commencement.

FELTHAM NORTH WARD

Commencing at the point where the southeastern boundary of East Bedfont Ward meets the southwestern boundary of Hounslow West Ward, thence generally southeastwards along said southwestern boundary to the Whitton to Ashford railway, thence southwestwards along said railway to the southeastern boundary of East Bedfont Ward, thence generally northwards and northeastwards along said boundary to the point of commencement.

FELTHAM SOUTH WARD

Commencing at the point where the southern boundary of the Borough meets the southeastern boundary of East Bedfont Ward, thence northwards and northeastwards along said Ward boundary and the southern boundary of Feltham North Ward to a point being the prolongation northwestwards of the access road to the rear of Nos 102-2 Hanover Avenue, thence southeastwards along said prolongation and said access road to a point opposite the rear boundary of the properties on the south side of Highfield Road, thence southeastwards to and along said boundary and the southern boundary of No 76 High Street to High Street, thence southwestwards along said street to Elmwood Avenue, thence generally southeastwards along said avenue to a point opposite the southeastern boundary of the Army Ordnance Depot, thence southwestwards to and along said boundary to Lower Feltham Brook, thence westwards along said brook to a point opposite the rear boundaries of Nos 12-1 April Close, thence southwards to and southwestwards along said boundaries and the rear boundaries of numbers 78-74 Harvest Road to the southern boundary of the access road to the rear of Nos 72-8 Harvest Road thence southwestwards along said boundary and continuing southwestwards along the rear boundary of No 6 Harvest Road and the southern boundary of No 2 Ludlow Road to the southeastern boundary of said road, thence southwestwards along said boundary to the eastern boundary of the Scouts' Hall, thence southeastwards along said boundary, the rear boundaries of Nos 63-91 Sunbury Road and the eastern boundary of No 7 Felthamhill Road to the southeasternmost corner of said property, thence southeastwards in a straight line to NG reference TQ 1016471431 being a point on the southern boundary of the Borough, thence generally westwards and northwards along said boundary to the point of commencement.

FELTHAM CENTRAL WARD

Commencing at the point where the southwestern boundary of Hounslow West Ward meets the southeastern boundary of the Borough, thence southeastwards

along said Borough boundary to a point being the prolongation northeastwards of the eastern boundary of No 77 Saxon Avenue, thence southwestwards along said prolongation and said boundary to Saxon Avenue, thence westwards along said avenue to a point being the prolongation northwards of the eastern boundary of No 48 Saxon Avenue, thence southwards along said prolongation and said boundary to the access road at the rear of Nos 42 to 72 Saxon Avenue, thence southeastwards along said access road to a point opposite the rear boundaries of Nos 62 to 48 Canterbury Road, thence southwestwards to and along said boundaries and continuing southwestwards along the southern boundary of the last mentioned property crossing Norman Avenue to the eastern boundary of No 46 Canterbury Road, thence southeastwards along said boundary and southwestwards along the rear boundary of said property to the northeastern boundary of No 44 Canterbury Road, thence southeastwards along said boundary to the rear boundary of said property, thence southwestwards along said boundary and the rear boundaries of Nos 42 to 32 Canterbury Road, thence westwards along the southern boundary of the last mentioned property crossing Lords Close to the northeastern boundary of No 30 Canterbury Road, thence southeastwards along said boundary to the rear boundaries of Nos 28 to 22 Canterbury Road, thence southwestwards along said boundaries to the southern boundary of No 20 Canterbury Road, thence westwards along said boundary crossing Barnlea Close to the northeastern boundary of No 18 Canterbury Road, thence southeastwards along said boundary to the rear boundaries of Nos 16 to 10 Canterbury Road, thence southwestwards along said boundaries to the southern boundary of No 8 Canterbury Road, thence westwards along said boundary crossing Newgate Close to the northeastern boundary of No 6 Canterbury Road, thence southeastwards along said boundary to the rear boundary of No 4 Canterbury Road, thence southwestwards along said boundary and the rear boundary of No 2 Canterbury Road to the southwestern boundary of said property, thence northwestwards along said boundary to Canterbury Road, thence southwestwards along said road crossing Hampton Road West to the southeastern boundary of No 36 Hampton Road West, thence

continuing southwestwards along said boundary to the rear boundary of said property, thence northwestwards along said boundary and the rear boundaries of Nos 34 to 30 Hampton Road West and continuing northwestwards in a straight line to the rear boundary of No 24 Hampton Road West, thence northwestwards along said boundary to Mount Road, thence southwestwards along said road to a point opposite the rear boundaries of Nos 6-2 Willow Cottages, thence northwestwards to and along said boundaries to the northwestern boundary of No 14 Hampton Road West, thence northeastwards along said boundary to Hampton Road West, thence northwestwards along said road to Hounslow Road, thence southwestwards along said road to a point opposite the northeastern boundary of No 233 Hounslow Road, thence northwestwards to and along said boundary and southwestwards along the rear boundary of said property to the access road at the rear of Nos 231 to 183 Hounslow Road, thence southwestwards and southeastwards along said access road to Hounslow Road, thence southwestwards along said road to a point opposite the access road at the rear of Nos 163 to 117 Hounslow Road, thence westwards and southwestwards along said access road to the northern boundary of No 115 Hounslow Road, thence westwards along said boundary to the rear boundary of said property, thence southwestwards along said boundary and the rear boundaries of Nos 113 to 67 Hounslow Road, thence eastwards along the southern boundary of the last mentioned property to the access road at the rear of Nos 65 to 49 Hounslow Road, thence southwards along said access road to Park Road, thence eastwards along said road to Hounslow Road, thence southwards along said road to Sunbury Way, thence southwestwards along said way to Felthamhill Road, thence northwestwards along said road to the eastern boundary of Feltham South Ward, thence generally northwards along said boundary to the southern boundary of Feltham North Ward, thence northeastwards along said boundary to the southwestern boundary of Hounslow West Ward, thence generally southeastwards along said boundary to the point of commencement.
