SHROPSHIRE

The Shrewsbury and Atcham Borough Council made an Order dated 10 March 1983 dissolving the present grouping of the Parishes of Cardington, Church Preen and Hughley under a common Parish Council; establishing a new and separate Parish Council for the Parish of Cardington; and grouping the Parishes of Church Preen, Hughley and Kenley together under a new common Parish Council, named the Church Preen Hughley and Kenley Parish Council.

ALTERATION TO BOUNDARIES OF LOCAL AUTHORITIES PART IV

THE FOLLOWING BOUNDARY CHANGES CAME INTO EFFECT ON OR BEFORE 1 APRIL 1983.

AVON AND SOMERSET

The Avon and Somerset (Areas) Order 1983 (SI 1983 No 84) alters the boundaries between the Counties of Avon and Somerset (and of the Districts of Woodspring and Sedgemoor).

AVON

The Kingswood (Parishes) Order 1982 (SI 1982 No 1599) effects some transfers as between parishes and part of the district not comprised in any parish.

BEDFORDSHIRE

The Kempston and Kempston Rural (Areas) Order 1982 (SI 1982 No 1746).
A watercourse forming a boundary between two local government areas having been altered pursuant to statutory powers, this order declares that the line for the time being of the centre of the watercourse as altered shall be the new boundary.

CHESHIRE

The Macclesfield and Vale Royal (Areas) Order 1982 (SI 1982 No 1759) transfers part of the District of Vale Royal (and the Parish of Antrobus) to the Borough of Macclesfield (and the Parish of Aston by Budworth).

CLEVELAND AND DURHAM

The Cleveland and Durham (Areas) Order 1982 (SI 1982 No 1658) alters the boundary between the Counties of Cleveland and Durham by transferring

- (a) an area from the County of Cleveland, the Borough of Stockton-on-Tees and the Parish of Grindon to the County of Durham, the District of Sedgfield and the Town of Sedgfield;
- (b) an area from the County of Durham, the District of Sedgfield and the Parish of Stillington to the County of Cleveland, the Borough of Stockton-on-Tees and the Parish of Whitton;

and effects minor consequential transfers from the Parish of Stillington to the Parish of Foxton and Shotton. (The Parishes of Foxton and Shotton and Stillington further affected by a parish review order - see Sedgfield (Parishes) Order 1983 under Durham below.)

CORNWALL

The Restormel (Parishes) Order 1983 (SI 1983 No 460) effects:

- (a) the constitution of eight new parishes, two (Grantock and Newquay) in the area of the former urban district of Newquay, five (Fowey, Mevagissey, St Blaise, Treverbyn and Tywardreath) in the area of the former borough of St Austell with Fowey, and one other (Grampound with Creed); and

(b) transfers as between parishes.

These changes involve the abolition of the Parishes of Creed and Grampound.

An area of the former borough of St Austell with Fowey will remain unparished.

DERBYSHIRE

The Erewash (Parishes) Order 1982 (SI 1982 No 1256) effects some adjustments between parishes and between parishes and a part of the borough not comprised in any parish.

The South Derbyshire (Parishes) Order 1983 (SI 1983 No 329) effects:

- (a) the constitution of a new parish of Sinfin Moor from parts of the Parishes of Barrow upon Trent and Twyford and Stenson;
- (b) transfers as between parishes, involving the abolition of the Parish of Derby Hills; and
- (c) adjustments between parishes and the part of the district not included in any parishes.

The West Derbyshire (Parishes) Order 1983 (SI 1983 No 434) constitutes two new Parishes, Cromford and Matlock Town, in parts of the area of the former urban district of Matlock and transfers a small part of such area to a parish constituted by a similar Order (SI 1980 No 363). Two small areas of the former urban district will still remain unparished.

DURHAM

The Easington (Parishes) Order 1983 (SI 1983 No 412) effects:

- (a) the constitution of five new parishes, one (Seaham) in the area of the former urban district of Seaham, three (Trimdon Foundry, Wheatley Hill and Wingate) in the area of the existing parish of Wingate and one (Easington Village) in part of the area of the existing parish of Easington (renamed Easington Colliery); and
- (b) transfers as between parishes.

These changes involve the abolition of the parishes of Cold Hesledon and Wingate.

The Sedgefield (Parishes) Order 1983 (SI 1983 No 433) effects:

- (a) the constitution of a new parish of Middridge Village
- (b) transfers as between parishes, involving the abolition of the parishes of Butterwick and Oldacres, Elstob, Embleton, Foxton and Shotton, Mainsforth, Preston-le-Skerne, Stillington and Woodham.

HEREFORD & WORCESTER

The Parish of Feckenham Order 1983 (SI 1983 No 192) Constitutes a new parish, viz the Parish of Feckenham in the Borough of Redditch.

HUMBERSIDE

The Boothferry (Parishes) Order 1983 (SI 1983 No 96) effects:

- (a) the constitution of five new parishes, namely the Parish of Goole, comprising the area of the former borough of Goole and some other areas, and the Parishes of Eastoft, Garthorpe and Fockerby, Luddington and Haldenby, and Twin Rivers; and
- (b) other transfers as between parishes.

These changes involve the abolition of the Parishes of Adlingfleet, Fockerby, Garthorpe, Haldenby, Luddington, Ousefleet and Whitgift, and both parishes of Eastoft.

The Glanford (Parishes) Order 1982 (SI 1982 No 1747) constitutes:

- (a) a new parish, namely the Parish of New Holland, from part of the parish of Barrow upon Humber and
- (b) two transfers between parishes.

KENT

The Gillingham and Swale (Areas) Order 1982 (SI 1982 No 1814)
Transfers part of the Parish of Upchurch from the Borough of Swale to the Borough of Gillingham.

The Swale (Parishes) Order 1982 (SI 1982 No 1864) effects:

- (a) the constitution of six new parishes, four (Eastchurch, Leysdown, Queenborough and Warden) in parts of the area of the former borough of Queenborough-in-Sheppey, and two others (Graveney with Goodnestone, and Milstead and Kingsdown);
- (b) transfers as between parishes; and
- (c) adjustments between parishes and a part of the borough not comprised in any parish.

These changes involve the abolition of the parishes of Faversham Without, Goodnestone, Graveney, Kingsdown and Milstead.

LANCASHIRE

The Burnley (Parishes) Order 1982 (SI 1982 No 1405)

- (a) abolishes the Parish of North Town transferring its area to the Parish of Simonstone;
- (b) transfers part of the Parish of Habergham Eaves, to the Parish of Dunnockshaw.

The West Lancashire (Parishes) Order 1982 (SI 1982 No 1865) effects:

- (a) the constitution of four new parishes, three in parts of the area of the former urban district of Ormskirk and the other in part of the area of the former urban district of Skelmersdale and Holland;
- (b) the transfer of part of a parish to another parish;
- (c) some adjustments between parishes and the part of the district not comprised in any parish.

LEICESTERSHIRE

The Charnwood (Parishes) Order 1982 (SI 1982 No 196)

- (a) constitutes two new parishes, viz the Parish of Hathern, comprising part of the area of the former borough of Loughborough, and the Parish of Shepshed, comprising the area of the former urban district of Shepshed;
- (b) effects transfers as between some parishes in the borough.

MERSEYSIDE

The Knowsley (Parishes) Order 1983 (SI 1983 No 138)

Constitutes a new parish, viz the Parish of Prescot, in the Borough of Knowsley. The new parish will comprise the greater part of the area of the former urban district of Prescot and parts of the Town of Whiston and of the former urban district of Huyton-with-Roby. Small areas of the former urban district of Prescot are included in the Town of Whiston. Other parts will remain unparished.

NORFOLK

The Breckland (Parishes) Order 1982 (SI 1982 No 1235) effects some transfers as between parishes.

NORTH YORKSHIRE AND WEST YORKSHIRE

The North Yorkshire and West Yorkshire (Areas) Orders 1982 (SI 1982 No 1813) transfers the Parish of Kildwick from the County of West Yorkshire (and the City of Bradford) to the County of North Yorkshire (and the District of Craven).

NORTH YORKSHIRE

The Selby (Parishes) Order 1983 (SI 1983 No 167)

- (a) constitutes a new Parish of Tadcaster, comprising the existing parishes of Tadcaster East and Tadcaster West other than areas included in (b)
- (b) effects the transfer of parts of certain parishes, to other parishes.

SOMERSET

The Sedgemoor (Bridgwater Without) Order 1982 (SI 1982 No 1618) provides that part of the Parish of Bridgwater Without shall cease to form part of any parish.

The West Somerset (Parishes) Order 1983 (SI 1983 No 288), effects:

- (a) the constitution of a new parish of Minehead in the area of the former urban district of Minehead; and
- (b) the transfer of parts of parishes to other parishes.

SURREY

The Betchworth (Area) Order 1982 (SI 1982 No 1748) provides that part of the Parish of Betchworth (in the District of Mole Valley) shall cease to form part of any parish.

WEST SUSSEX

The Crawley, Horsham and Mid Sussex (Areas) Order 1982 (SI 1982 No 1636) alters the boundaries between the Borough of Crawley and the Districts of Horsham and Mid Sussex by transferring :

- (a) areas from the two Districts to the Borough
- (b) a small area from the Borough to the District of Mid Sussex.

WILTSHIRE

The Thamesdown (Parishes) Order 1982 (SI 1982 No 1369) effects:

- (a) the constitution of a new parish, namely the Parish of Covingham, comprising parts of the Parishes of Stratton St Margaret and Wanborough;
- (b) the transfer of parts of parishes to other parishes; and
- (c) adjustments between certain such parishes and the part of the borough not comprised in any parish.
