ALTERATIONS TO BOUNDARIES OF LOCAL AUTHORITIES--PART IV

THE FOLLOWING BOUNDARY CHANGES CAME INTO EFFECT ON OR BEFORE 1 APRIL 1985

BEDFORDSHIRE

The Bedfordshire (Areas) Order 1984 (SI 1984 No 2023) transfers two areas from the district of Mid Bedfordshire to the district of South Bedfordshire, one from the parish of Battlesden to the parish of Hockliffe, and the other from the parish of Pulloxhill to the parish of Barton-le-Clay.

The Mid Bedfordshire (Parishes) Order 1984 (SI 1984 No 2003):-

- (a) creates five new parishes to be called:

Campton and Chicksands	Stondon
Flitton and Greenfield	Wrestlingworth and Cockayne Hatley
Shillington	

- (b) abolishes the following parishes:

Campton	Flitton
Chicksands	Higham Gobion
Cockayne Hatley	Shillington and Stondon
Upper Stondon	Wrestlingworth

- (c) transfers areas between other parishes.

The South Bedfordshire (Parishes) Order 1985 (SI 1985 No. 57):

- (a) creates a new parish of Dunstable from part of the former borough of Dunstable;
- (b) transfers the rest of the former borough to the parish of Houghton Regis;
- (c) transfers areas between other parishes.

CAMBRIDGESHIRE

The South Cambridgeshire (Parishes) Order 1984 (SI 1984 No. 1877):

- (a) creates a new parish of Oakington and Westwick from parts of the parishes of Oakington, Westwick, Histon and Longstanton;
- (b) abolishes the existing separate parishes of Oakington and Westwick;
- (c) transfers areas between other parishes.

CORNWALL

The Carrick (Parishes) Order 1985 (SI 1985 No. 54) transfers areas between parishes in the district.

The Kerrier (Parishes) Order 1985 (SI 1985 No. 142):

- (a) creates eight new parishes from the area of the former urban district of Camborne - Redruth, to be called:

Camborne	Lanner
Carharrack	Portreath
Carn Brea	Redruth
Illogan	St. Day

- (b) creates two new parishes of Gweek and Porthleven from parts of other parishes;
- (c) transfers areas between other parishes.

DERBYSHIRE

The Derbyshire and Nottinghamshire (Areas) Order 1985 (SI 1985 No. 120):

- (a) transfers part of the county of Nottinghamshire, of the borough of Broxtowe and of the unparished area of the former urban district of Beeston and Stapleford to the county of Derbyshire and to the borough of Erewash;
- (b) transfers (within Derbyshire):
- (i) parts of the borough of Erewash and of the parish of Little Eaton to the district of Amber Valley and to the parish of Duffield;
- (ii) parts of the district of Amber Valley to the borough of Erewash:
- (a) areas of the parishes of Duffield and Holbrook to the parish of Little Eaton;
- (b) an area of the parish of Mapperley to the parish of West Hallam;
- (c) an area of the parish of Shipley to the unparished area of the borough.

DEVON

The Mid Devon, South Hams and Teignbridge (Areas) Order 1985 (SI 1985 No. 52) makes minor alterations in the boundaries of the districts of Mid Devon, South Hams and Teignbridge, affecting the parishes of:

Ashburton	Newton St. Cyres
Buckfastleigh	Staverton
Dean Prior	Whitestone

DORSET

The North Dorset (Parishes) Order 1985 (SI 1985 No 55) transfers areas between parishes in the district.

DURHAM

The Durham and Easington (Areas) Order 1985 (SI 1985 No. 42) transfers two areas of the parish of Shadforth in the city of Durham to the district of Easington, and to the parishes of Shotton and Wheatley Hill respectively.

The Chester-le-Street (Parishes) Order 1984 (SI 1984 No 1682):

- (a) creates a new parish to be called Bournmoor from the areas of the existing parishes of Bournmoor, Lambton and South Biddick;
- (b) transfers small areas between the parishes of Great Lumley, Little Lumley, Ouston, Pelton and Urpeth;
- (c) transfers areas between the unparished part of the former urban district of Chester-le-Street and the parishes of Waldrige and North Lodge.

ESSEX

The Braintree, Chelmsford and Colchester (Areas) Order 1985 (SI 1985 No 133) makes minor alterations to the boundary between the district of Braintree and the boroughs of Chelmsford and Colchester. The parishes of Boreham, Copford, Feering, Hatfield Peverel and Marks Tey are affected.

The Braintree (Parishes) Order 1985 (SI 1985 No 325) transfers areas between parishes, and between the unparished area of the former urban district of Braintree and Bocking and the parish of Black Notley.

GREATER MANCHESTER

The Bolton (Parishes) Order 1984 (SI 1984 No 2044) creates a new parish of Westhoughton from part of the area of the former urban district of Westhoughton, and transfers areas between the parishes of Blackrod and Horwich.

HAMPSHIRE

The Hampshire (Areas) Order 1985 (SI 1985 No 228) alters the boundaries of the City of Winchester with the boroughs of Eastleigh, Test Valley and Basingstoke and Deane, and with the district of East Hampshire. The following parishes are affected:

WINCHESTER:	Micheldever, Hambledon, West Meon, Old Alresford, Otterbourne, Hursley and Crawley.
EASTLEIGH:	(the unparished area).
TEST VALLEY:	Kings Somborne
BASINGSTOKE & DEANE:	Woodmancott
EAST HAMPSHIRE:	Clanfield, Froxfield & Medstead.

The Basingstoke and Deane (Parishes) Order 1985 (SI 1985 No. 179):

- (a) creates three new parishes to be called:

Ashford Hill with Headley

Chineham

Hannington;

- (b) transfers areas between other parishes;
- (c) transfers areas between the unparished part of the former municipal borough of Basingstoke and certain parishes.

The Basingstoke and Deane (Parish of Woodmancott) Order 1985 (SI 1985 No 494).

The Hampshire (Areas) Order 1985 transfers part of the parish of Woodmancott to the city of Winchester. This order transfers the remainder to the parish of Candovers (within the borough), and abolishes the parish.

The East Hampshire (Parishes) Order 1984 (SI 1984 No 2025) transfers part of the parish of Whitehill to the parish of Greatham.

The New Forest (Parishes) Order 1985 (SI 1985 No. 150) creates a new parish of Ashurst and Colbury from parts of the parish of Totton and Eling and transfers parts of the parish of Netley Marsh to the parish of Totton and Eling.

The Winchester (Parishes) Order 1985 (SI 1985 No. 154):

- (a) creates three new parishes in the city of Winchester to be named Badger Farm, Headbourne Worthy and South Wonston;
- (b) abolishes the parishes of Headbourne Worthy (as constituted prior to 1st April 1985) and Abbots Barton;
- (c) transfers areas between parishes in the city;
- (d) transfers areas between unparished parts of the city and the parish of Olivers Battery.

HEREFORD AND WORCESTER

The Hereford & Worcester (Areas) Orders 1985 (SI 1985 No. 56) makes minor alterations in the boundaries of the districts of Leominster, Malvern Hills, South Herefordshire, Wychavon and Wyre Forest and affects the parishes of:

Humber, Stanford with Orleton -
Astley and Dunley, Kempsey, Pencombe with Grendon Warren
Shelsby Kings, Woolhope, Yarkhill -
Brockhampton, Westhide, Weston Beggard -
Drakes Broughton and Wadborough, Hartlebury, Norton juxta Kempsey -
Stourport-on-Severn.

It also realigns a parish boundary in the district of Wychavon, affecting the parishes of Norton juxta Kempsey, and Drakes Broughton and Wadborough.

The Wychavon (Parishes) Order 1985 (SI 1985 No 164) creates a new parish of Cookhill and transfers areas between parishes.

HERTFORDSHIRE

The Dacorum and Three Rivers (Areas) Order 1985 (SI 1985 No 27) transfers part of the parish of Abbots Langley in the district of Three Rivers to the borough of Dacorum and to the parish of Nash Mills.

The East Hertfordshire and Welwyn Hatfield (Areas) Order 1985 (SI 1985 No 51) makes minor alterations in the boundary between the districts of East Hertfordshire and Welwyn Hatfield, affecting the parishes of Datchworth, Tewin and Welwyn.

The Dacorum (Parishes) Order 1985 (SI 1985 No 401) transfers areas between parishes, and between the unparished area of the former borough of Hemel Hempstead and the parishes of Bovington, Great Gaddesden and Nettleden with Potten End.

The North Hertfordshire (Parishes) Order 1985 (SI 1985 No 286):

- (a) transfers areas between the parishes of Clothall, Graveley, Holwell, Ickleford, Pirton, Weston and Wymondley;
- (b) transfers part of the parish of Clothall to the unparished area of Baldock;
- (c) transfers parts of the unparished area of Letchworth to the parishes of Graveley and Radwell.

HUMBERSIDE

The Humberside and North Yorkshire (Areas) Order 1984 (SI 1984 No. 1906):

- (a) makes a minor alteration in the boundary between the counties of Humberside and North Yorkshire by transferring a small area from the borough of Boothferry to the district of Selby, and from the parish of Pollington to the parish of Balne.
- (b) transfers a very small area in the county of Humberside from the East Yorkshire borough of Beverley to the borough of Boothferry, and from the parish of South Cave to the parish of Broomfleet.

ISLE OF WIGHT

The Medina (Parishes) Order 1985 (SI 1985 No 180) creates four parishes (Cowes, Gurnard, St Helens and Wootton) in the hitherto unparished borough of Medina.

KENT

The Canterbury and Shepway (Areas) Order 1985 (SI 1985 No 20) transfers the Syngate Wood area of the parish of Stelling Minnis in the district of Shepway to the city of Canterbury and to the parish of Waltham.

The Gravesham (Parishes) Order 1984 (SI 1984 No 2026) transfers areas:

- (a) between the parishes of Cobham, Higham and Shorne; and
- (b) between the unparished area of the former borough of Gravesend and the parishes of Meopham, Cobham and Shorne.

The Tunbridge Wells (Parishes) Order 1984 (SI 1984 No 2047) transfers areas between parishes, and between the unparished area of the former municipal borough of Royal Tunbridge Wells and the parishes of Speldhurst and Pembury.

LEICESTERSHIRE

The Charnwood (Parishes) Order 1985 (SI 1985 No. 269) alters the boundary between the parishes of Mountsorrel and Rothley.

NORTH YORKSHIRE

The Scarborough (Parishes) Order 1984 (SI 1984 No 2045):

- (a) creates four new parishes:
 - Broxa-cum-Troutsdale
 - Darncombe-cum-Langdale End
 - Grosmont
 - Osgodby
- (b) the separate parishes of Broxa and Troutsdale are abolished;
- (c) transfers land between other parishes, and between the unparished area of the former municipal borough of Scarborough and adjoining parishes.

OXFORDSHIRE

The Cherwell and West Oxfordshire (Areas) Order 1985 (SI 1985 No 21) transfers part of the parish of Kidlington in the district of Cherwell to the district of West Oxfordshire and to the parish of Bladon.

The West Oxfordshire (Parishes) Order 1985 (SI 1985 No. 181):

- (a) abolishes the parish of Carterton and Black Bourton;
- (b) creates two separate new parishes named Carterton and Black Bourton;
- (c) abolishes the parish of Hensington Without, and transfers its area to the town of Woodstock;
- (d) transfers other areas between parishes.

SOMERSET

The Sedgemoor and Taunton Deane (Areas) Order 1984 (SI 1984 No. 1793):

- (a) alters the boundary between the borough of Taunton Deane and the district of Sedgemoor. The parishes of Lyng, Middlezoy, North Petherton, Othery and Stoke St Gregory are affected;
- (b) creates a new parish of Burrowbridge in the borough from areas transferred from the district and part of Stoke St Gregory;
- (c) effects a minor transfer between the parishes of Middlezoy and Othery.

STAFFORDSHIRE

The East Staffordshire (Parishes) Order 1985 (SI 1985 No. 163):

- (a) creates a new parish of Hoar Cross from parts of the parishes of Abbots Bromley, Newborough and Yoxall;
- (b) transfers other areas between parishes, and between the unparished area of the former county borough of Burton upon Trent and the parishes of Branston, Outwoods and Stretton.

SUFFOLK

The Suffolk Coastal District (Parishes) Order 1984 (SI 1984 No 2046):

- (a) the parishes of Dallinghoo Wield and Havergate Island are abolished, and their areas transferred to the parishes of Dallinghoo and Orford respectively;
- (b) transfers, many of them of small areas, are made affecting over 50 parishes.

SURREY

The Tandridge (Parishes) Order 1984 (SI 1984 No 1560) transfers an area from Lingfield parish to Crowhurst Parish, and part of the unparished area of the former urban district of Caterham and Warlingham to the parish of Chelsham and Farleigh.

WEST SUSSEX

The Adur, Arun and Worthing (Areas) Order 1985 (SI 1985 No. 90) makes minor changes in the boundary between the borough of Worthing and the districts of Adur and Arun, with a small consequential realignment of parish boundaries within the former district. The parishes of Lancing and Sompting in the district of Adur and those of Clapham and Ferring in the district of Arun are affected.

The Arun and Chichester (Areas) Order 1985 (SI 1985 No. 41) makes alterations in the boundary between the districts of Arun and Chichester, and affects the parishes of Bersted, North Mundham, Oving and Pagham.

The Horsham and Mid Sussex (Areas) Order 1985 (SI 1985 No. 28) transfers two areas of the parish of Woodmancote in the district of Horsham to the district of Mid Sussex, one to the parish of Albourne and the other to the parish of Poynings.

The Arun (Parishes) Order 1985 (SI 1985 No. 119):

- (a) creates three new parishes to be named Aldwick, Bognor Regis, and Felpham;
- (b) abolishes the parish of Tortington;
- (c) transfers other areas between parishes;
- (d) transfers parts of the area of the former urban district of Bognor Regis to parishes.
