Thank you for your which we received on 18 February 2013, requesting information under the Freedom of Information Act 2000.

You have requested:

“...a list of all boundary changes between local authorities, from the period 1992-2010, that involve any exchange of population and the number of that population.”

The Commission's responsibility, as was that of its predecessors, is to make recommendations to the Secretary of State for any changes to the boundaries between local authority areas that it considers desirable having regard to certain statutory criteria. The Commission is not the decision-making body in relation to such changes - that task falls to the Secretary of State for Communities and Local Government and, ultimately, Parliament. Accordingly, the Commission holds only some of the information you require.

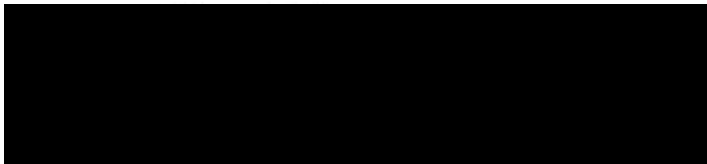
