The Oxford (Parishes) Order 2008

Made - - - - 12th February 2008

Coming into force in accordance with article 1(2)

The Secretary of State, in exercise of the powers conferred by sections 14 and 23 of the Local Government and Rating Act 1997(a), makes the following Order:

Citation, commencement and interpretation

- 1.— (1) This Order may be cited as the Oxford (Parishes) Order 2008.
- (2) It shall come into force—
 - (a) for the purposes of proceedings preliminary or relating to elections of parish councillors to be held on the ordinary day of election in 2008, on the day after that on which it is made;
 - (b) for all other purposes, on 1st April 2008.
- (3) In this Order “maps 1 and 2” mean the maps prepared by the Department for Communities and Local Government, marked “Maps referred to in the Oxford (Parishes) Order 2008” and deposited in accordance with regulation 6(1) of the Local Government (Parishes and Parish Councils) Regulations 1999(b).

Alterations to Parish Areas

- 2.— (1) The area shown in blue and designated by the letter ‘A’ on Map 1 shall cease to be part of the unparished area of the City of Oxford and shall become part of the parish of Risinghurst and Sandhills.
- (2) The area shown in green and designated by the letter ‘B’ on Map 2 shall cease to be part of the parish of Littlemore and shall become part of the unparished area of the City of Oxford.

Order Date

3. 1st April 2008 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999.

EXPLANATORY NOTE

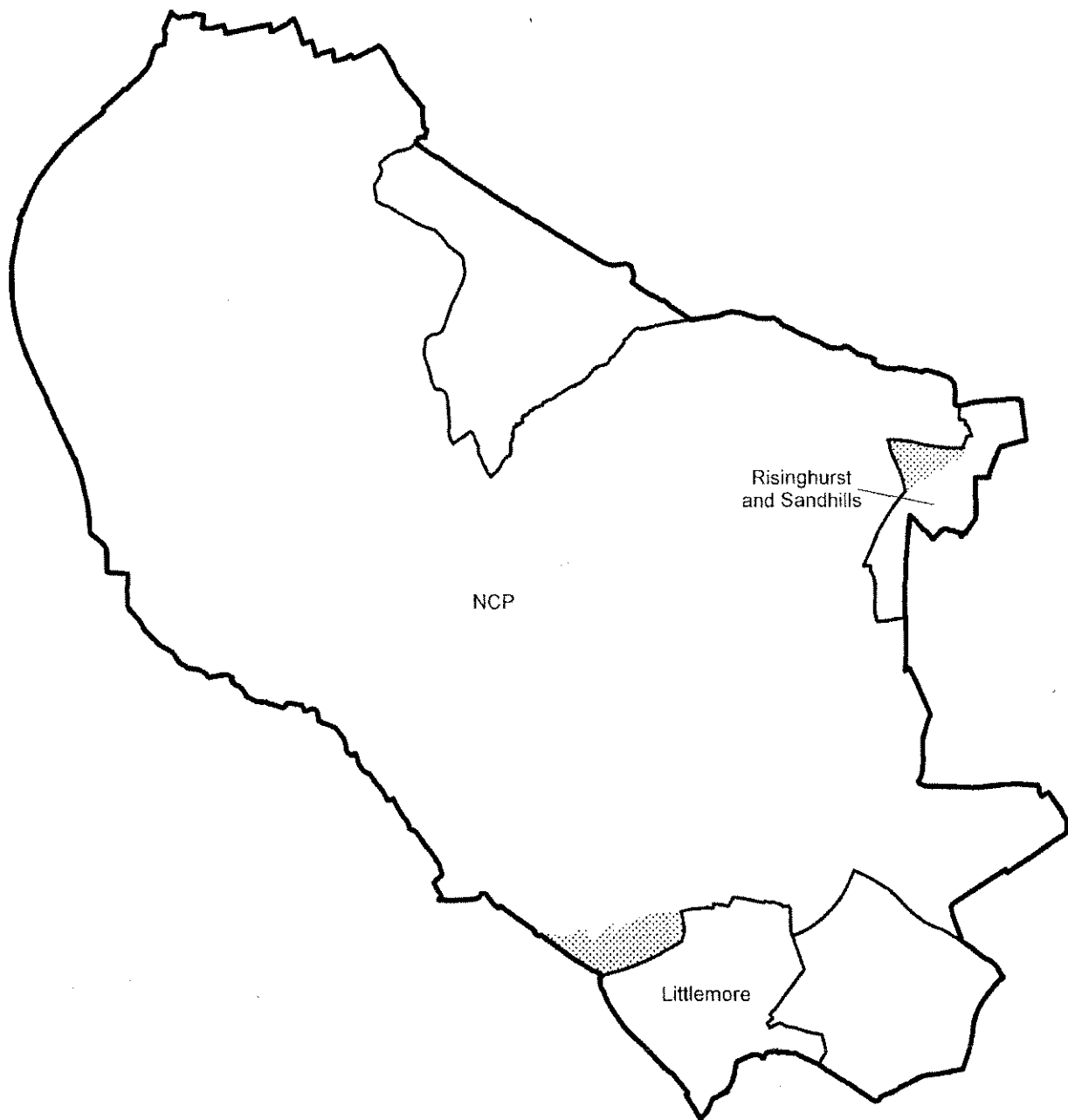
(This note is not part of the Order)

This Order gives effect (without modification) to recommendations sent to the Secretary of State for alterations to parish areas within the city of Oxford. A map forming part of this note gives a general guide to the areas concerned.

Article 2 makes alterations to the areas of the parishes of Risinghurst and Sandhills, and Littlemore.

Article 3 specifies 1st April 2008 as the Order date for the purposes of the Local Government (Parishes and Parish Councils) Regulations 1999, which make provision of general application in relation to orders such as this Order.

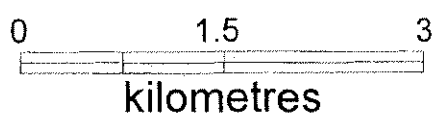
