

## Cambridgeshire Constabulary has made good progress in achieving its savings for the comprehensive spending review period.

Her Majesty's Inspectorate of Constabulary (HMIC) has today published a report on Cambridgeshire Constabulary's progress in meeting the challenges of the 2010 comprehensive spending review.

A thematic report, *Policing in Austerity: One Year On,* found that police forces across England and Wales have risen to the financial challenge of the spending review, cutting their spending while largely maintaining the service they provide to the public; but HMIC has some concerns about whether all forces have transformed their efficiency to the extent that this can be sustained through the next three years (and into future spending reviews).

Based on the data provided by the force, HMIC found that:

- **Money**: Cambridgeshire Constabulary needs to save £11 million between March 2011 and March 2015. By spring 2012 they had planned how to save 100% of this amount.
- People: The constabulary is planning to cut its total workforce number (i.e. police officers, police staff and police community support officers) by 510 between March 2010 and March 2015.
- 150 of these will be police officer posts; this means there will be 10% fewer officers in Cambridgeshire by 2015 (which is in line with the average officer reduction across England and Wales).
- **The front line**: By 2015 73% of its workforce will be in frontline roles. This is broadly in line with most other forces.
- The proportion of officers in frontline roles will increase between March 2010 and March 2015 (from 82% to 88%). Again, this percentage is similar to the national figure.
- Collaboration: Cambridgeshire Constabulary has recently entered an
  extensive programme of collaboration with Bedfordshire Police and
  Hertfordshire Constabulary. This alliance has already delivered savings
  through sharing services such as major crime and professional standards.
  Further savings are expected as other policing units are shared later this
  year.
- **Crime**: The constabulary continues to drive down crime, with the third highest reduction (out of 42 forces) between December 2010 and December 2011.

• Victim satisfaction: 86% of victims in Cambridgeshire were satisfied with the service from Cambridgeshire Constabulary. This is above the figure for England and Wales as a whole.

HM Inspector of Constabulary for the Eastern Region, Zoe Billingham, said:

"Cambridge Constabulary has put in place a comprehensive change programme to manage the reductions in its budget. This should allow it not only to balance the books, but also to increase the proportion of its workforce in frontline, crime-fighting roles. As a result they are in a good position to achieve their savings target by March 2015.

"Although the force is reducing its workforce (and this includes cutting police officer posts), it plans to protect frontline services by increasing the proportion of officers who work in crime-fighting roles. This will help as Cambridgeshire Constabulary works to bring down crime and keep local communities safe."
