Introduction


The Acute Visiting Service shall provide a rapid response service for Patients requiring a home visit as determined by the Patients own GP practice. Badger will provide the service between the hours of 14.30 and 18:00 Monday to Friday.

Providing the Service


- Requests will be made to Badger following the initial triage within the GP practice. Calls will be received on the Healthcare Professional line (HCP) 0121 766 2116 and in some cases a fax may be sent.
- The call will be answered" Badger Healthcare Professional Line"
- The caller will normally state that the call is for the AVS scheme and advise that a fax has been sent/will be sent. The fax machine is situated on Mission Control.

Receiving the Call

- 1. Record the Patients GP and Surgery> Check the timeline to ensure it states Cover- **Home**Visit ONLY. The scheme also includes those patients registered as temporary residents.
- 2. Complete all of the Patients demographics starting with the Patients Date of Birth
- 3. In the **Relationship to Caller**>record the name of the GP making the referral and GPs contact number (preferably a mobile phone)
- 4. Document the reason for the visit- Ask the caller what the priority is?
- If there is additional information, notes etc you must record the following" ADDITIONAL INFORMATION AVAILABLE PLEASE CALL THE CALL CENTRE TO ACCESS THIS INFORMATION"
- 6. Click on Store Call
- 7. Next select Case Type "Home Visit-AVS"



- Click on "Next"
- Select "Urgent" or "Emergency" and click "Next"



- 10. You will now see the despatch Destination Screen Click on the "x" which on the right hand side of the screen.
- 11. The call will now be showing in Despatch. Inform your Team Leader there is an AVS visit.
- 12. The Call handler will then call the Patient to advise we have received their call.
- 13. This information will be recorded using the comfort call facility.
- 14. The Team Leader will despatch the call to the AVS Home Visiting car.
