Reference: FOI 494 Freedom of Information request

Thank you for your email, which we received on 4 August 2023. Your request has been handled under the Freedom of Information Act 2000.

You asked us:

To provide the investigation process/protocol that the Prisons and Probation Ombudsman follows when advised of a death in custody, including:

- a) At what point following notice of a death in custody (or within 14 days of release from it) is an Investigation Officer appointed.
- b) When is the family/ next of kin (NOK) of the deceased identified.
- c) At what point is the family/ NOK informed of the death and by whom.
- d) At what point in the process are the family/ NOK personally visited by a representative of the PPO.
- e) When are the family/ NOK given the direct contact details of the investigation officer or family liaison officer.
- f) What written information in the form of leaflet(s) are the family/ NOK given by the PPO setting out their rights and explaining the death in custody investigation process.

Our response:

We have searched our records and hold some of the requested information on the above questions.

Some information cannot be disclosed as exemptions apply.

A copy of some of the information that you requested is enclosed with our response.

Where information has been withheld because exemptions apply, the exemptions and reasons are described below.

The exemptions applied, under the Freedom of Information Act, are Section 21(1) 'Information accessible by other means' and Section 40(2) 'Personal information'.

The 'information accessible by other means' exemption applies because part of the information you have requested, for questions b) and c) is available at www.gov.uk, in

Prison Service Instruction 64/2011 'Management of prisoners at risk of harm to self, to others and from others (Safer Custody)'.

The 'personal information' exemption applies because some of our staff would be identifiable if their names were provided. We consider that disclosing this information would constitute a breach of one or more principles in the Data Protection Act 1998 referred to in FOIA 2000.

In applying these exemptions, we do not have to apply a public interest test to the disclosure of this information.

You asked us:

To provide a copy of the PPO leaflet given to the family/next of kin

Our response:

We have searched our records and we hold the requested information on the above question.

A copy of the information that you requested is enclosed with our response.

You asked us:

When does the PPO provide the family/next of kin with a copy of the post mortem report?

Our response:

Following a search of our records, the information you requested is not held by us. We suggest you contact the Coroners' Society of England and Wales, as they may be able to provide this data, and their details are as follows:

The Prisons and Probation Ombudsman (PPO) carries out **independent investigations** into complaints and deaths in custody. The detailed role and responsibilities of the PPO are set out in our office's Terms of Reference. The PPO has three main duties:

- to investigate complaints made by prisoners, young people in detention (prisons and secure training centres), offenders under probation supervision and individuals detained under immigration powers (detained individuals)
- to investigate deaths of prisoners, young people in detention, approved premises' residents and detained individuals due to any cause, including any apparent suicides and natural causes
- to **investigate deaths** of **recently released prisoners** that occur within 14 days of release from prison (except homicide)

The purpose of these investigations is **to understand what happened**, **to correct injustices** and **to identify learning** for the organisations whose actions we oversee so that the PPO makes a significant contribution to safer, fairer custody and offender supervision.

We may use or share your data only to the necessary extent when conducting our independent investigations in the exercise of our official authority. We will share your data with third parties (e.g. the prison) in order to make sure the information is accurate; to prevent or detect failings; and to identify lessons learnt. We may sometimes need to share your data with third parties if required by law. We only keep your personal data for as long as it is needed, as set out in our data retention policy. I am sorry to be writing to you under these circumstances and please accept my condolences. I am writing to tell you about the Prisons and Probation Ombudsman's investigation into the death of [Title] [Deceased's Surname].

What does the Prisons and Probation Ombudsman (PPO) do?

The Prisons and Probation Ombudsman aims to make a significant contribution to safer, fairer custody and community supervision. One of the most important ways in which we work towards that aim is by carrying out **independent** investigations into deaths, due to any cause, of prisoners, young people in detention, residents of approved premises and detainees in immigration centres.

What is the purpose of the investigation?

The purpose of the investigation is to understand what happened leading up to [Title] [Deceased's Surname]'s death and identify how His Majesty's Prison and Probation Service (HMPPS) can improve their work in the future. We will write a report when we have finished our investigation and make recommendations for improvement, if necessary.

Please be aware that we are unable to share our findings before we issue the initial report. The reason is that findings can change if new information comes to light and we do not want to share inaccurate information.

What happens next?

What can we investigate?

We can investigate prison issues that relate to [Title] [Deceased's Surname]'s death, as we oversee the work of the Prison Service. This may include prison healthcare, the suitability of his/her location within the prison, family liaison, the security arrangements for hospital escorts and whether compassionate release was considered (if applicable).

What can't we investigate?

We cannot investigate anything that is not linked to [Title] [Deceased's Surname]'s death, as it is not within the scope of the investigation. For example, other health issues, property issues or parole decisions.

We also cannot investigate action taken by the police, courts, hospital staff or Coroner, as we do not oversee their work. For example, his/her offence/arrest, remand/sentencing decisions, decisions made by hospital staff and the content of the post-mortem report.

What are the stages of the investigation?

- **1. Investigation:** The investigator will consider the evidence. They may interview key prison staff / healthcare staff / prisoners with relevant information.
- 2. Initial report: We will send you a copy of the initial report, if you request a copy. We will aim to complete the report by the end of [date]. If there is a delay, we will let you know. The report will include our findings and any recommendations we have made. This is a draft report and you will be asked to point out any incorrect facts. We will also send a copy to others involved in the investigation, including the Coroner.
- **3. Final report:** Once we have considered any responses to the initial report, we will produce a final report and send you a copy. If we have made any recommendations, we will attach HMPPS' response to our report so that you can see what action the prison has agreed to take.
- 4. Publication of the report: After the Coroner's inquest, we will publish an anonymised version of the report on our website at www.ppo.gov.uk. Please note that [Title] [Deceased's Surname] and [prison] will be named in the report. We do this because The Human Rights Act 1998 (Article 2) states that our investigations should be open to public scrutiny. In all our fatal incident investigations, including our investigation into [Title] [Deceased's Surname]'s death, the PPO aims to meet this requirement by being transparent and consistent. Please be aware that inquests are open to the public and media and therefore, this information will already be public.

What can we investigate?

We can investigate prison and probation issues, as we oversee their work. We can only investigate issues that we consider to be relevant to the circumstances of an individual's death. Where relevant, this may include the management of an individual's risk of suicide and self-harm, their mental health care in prison and other matters that may have impacted on their death.

What can't we investigate?

We cannot investigate action taken by the police, courts, hospital staff or Coroner, as we do not oversee their work. For example, the offence/arrest, remand/sentencing decisions, decisions made by hospital staff and the content of the post-mortem report.

The stages of the investigation are:

- **1. Investigation**: The investigator will consider the evidence. They may interview key prison staff, medical staff and prisoners.
- 2. Initial report: We will send you a copy of the initial report. We aim to complete the report by [date]. If there is a delay, we will let you know. This is a draft report.
