

Works update notice – utility trial holes, Aylesbury

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What are we doing?

As part of our preparatory works, we are continuing with our Ground Investigation (GI) and utility works. For this we need to carry out some utility trial holes and surveys. Some of these works will need to be carried out on the roads within the Aylesbury area.

When will these works take place?

The works will commence from November and continue into January 2021.

Below are the locations and intended dates of where and when the traffic management will be in place.

- 1. A418 Oxford Road 8.12.2020 and 04.01.2020 08.01.2021
- 2. A41 04.01.2021 08.01.2021 (Works completed outside of peak traffic times 7pm – 6am)
- 3. Blackgrove Road 11.01.2021

The timings of the works may differ depending on what we find as well as other external conditions such as the weather. We will work to reduce disruption where possible.






Location 2 - A41

What to expect: Rolling traffic lights at locations along the A41 towards Waddesdon village as works are completed outside of peak traffic times, between the hours of 7pm and 6am.

Examples of the traffic light systems and locations on the A41 are outlined on the maps below.






