

# Update on weekend closures to A412

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with Covid-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review.

## Weekend closures A412

We wrote to you back in July to inform you that we would be creating two new site entrances and building crossing points for a haul road:

- on the A412 near Denham Water Ski Club
- on Moorhall Road

This work is in preparation for the creation of a new haul road to support the construction of the Colne Valley Viaduct. In addition to the 2-way lights currently operating 24 hours a day for 3 months, during this period of work we will also be putting in place full weekend A412 road closures on two weekends. This work is being undertaken at weekends to reduce disruption and for the safety of the public.

Electronic traffic signs are currently placed on the A412 to provide updates for road users and will remain in place until works are complete.



## How will this affect me?

Please see the map below for the location of the diversion route to be used during the weekend road closures. Advance warning signage will be put out on the road ahead of the works to pre warn road users. The weekend closures on the A412 are to take place on 30 October and 06 November 21:00 Friday to 05:00 Monday.

There may also be a need for some local fencing to be installed around the works, depending upon their proximity to Public Rights of Way.
