



Notice of A404 road closure at Whielden Lane junction

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. Why are the works taking place now?

We have made a number of improvements to the roundabout junction of the A413, A404, and access into the Amersham vent shaft site. We wrote to you in the summer advising that the recently installed traffic lights would require a further local road closure of the A404 to complete the final testing. Following this works the traffic lights will be turned on, but temporarily covered, and then until the reopening of Whielden Lane.

What are we doing?

Before we begin construction of the vent shaft we need to connect, commission and test the new traffic lights. To do this we will need to close part of the A404 overnight from Monday 26 October 2020. Works will be carried out at night to minimise disruption to the road network. The road will be closed on a nightly basis from 9pm to 5am, for no longer than five consecutive nights. The activities will generate low levels of noise as we complete the connections and testing. These works will be advertised on the local highway verges in the form of advance warning signage.

Monday 26 October 2020 for a maximum of five nights

What to expect

Road closed from 9pm to 5am

Working hours Monday to Friday 9pm to 5am.

Some additional traffic on local diversion route roads.

What we will do

Access for emergency services and the crematorium will be provided at all times along the A404.

Work hard to ensure any impacts on residents are kept to a minimum.


