



## Notice of continued closure of Whielden Lane and overnight works on A404

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ### Why the continued closure to the end of March?

There have been delays to the utility services works on site, so we now need to keep Whielden Lane shut for another month. Keeping it closed allows us to do more work at one time than if it was carried out under single lane closures with traffic lights.

To support these works we will continue to run the bus replacement service from Gore Hill/A355 bus stops near the Tesco supermarket to the hospital. Monday to Saturday from 7am to 6.30pm on a half hourly basis. On Sundays a reduced hourly service will operate from 7.49am to 6.30pm.



## One-night closure of the A404

Fusion need to undertake works to survey the traffic management they installed last year, and we need to remove the temporary safety barrier along the A404. This will be done at night to reduce disruption to the A404. A diversion route will be in place.

The A404 will be closed on Wednesday 31 March 2021 between 9pm in the evening through to 5am the following morning.
