

Notice of Utility Works in Mixbury

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. We are writing to make you to give a brief update and make you aware of the next stage of work that will be undertaken by Western Power Distribution (WPD) on our behalf.

What are we doing

WPD have made significant progress since April 2020 on the 132kV OHL Diversion. This has included the setup of the site compound on A421/Featherbed Lane, installation of the underground cable ducting through fields, Horizontal Directional Drilling (HDD) works completion and high voltage towers foundations have begun to be installed.

WPD will pause works in September 2020 and then return to site in March 2021 to complete the diversion works. WPD are not going to install any of the high voltage towers in 2020. In March 2021 the overhead line works will recommence, the towers will be installed and diverted off the existing towers onto the underground cable section. WPD works are planned to be completed by August 2021.

How will this affect me?

The impact on you the local community for the remainder off this year is going to be relatively low. Day to day movements of staff & equipment between now and November will be minimal, as WPD have almost made all large deliveries. Please be aware that other parties are working in the area and using Featherbed Lane, which is not necessarily linked to WPD works. In March 2021 new permanent and temporary towers will be built and the overhead lines will be moved. WPD have made all the large deliveries but it is expected that a crane will be brought to site on multiple occasions on to carry out our large lifts.

WPD need to dig through Featherbed Lane, so WPD have decided to delay the works until early Mar ch 2021 and ask for a road closure to carry out the works safely and more efficiently. Application to the local authority will be made in October.

The works will be relocating the existing 132kV overhead line by undergrounding next to Tibbets farm.
