Notice of works on North Gower Street

High Speed Two (HS2) is the new high speed railway for Britain. We are continuing preparatory works for HS2 in your area, this includes utility works in the area west of Euston station.

North Gower Street – Utilities works between Drummond Street and Stephenson Way

In October we notified you of utilities works to install communication ducts and electrical power connections in the carriageway of North Gower Street. Due to unforeseen circumstances these works were delayed and will now take place from 7 January. Work will be carried out in phases, each lasting for approximately four weeks. Dates are indicative and may be subject to change, depending on progress.

Phase one: **7 January to 2 February** – Northbound lane, between the junctions of Drummond Street and Euston Street. During this stage there will be no right turn from Drummond Street into North Gower Street for vehicles travelling from Hampstead Road. Access to the southern section of North Gower Street will be via Cobourg Street and Euston Street.

Phase two: **3 February to 1 March** - Southbound lane, between the junctions of Drummond Street and Euston Street.

Phase three: **2 March to 5 April** – Northbound lane between the junctions of Euston Street and Stephenson Way.

Phase four: **6 April to 3 May** – Southbound lane between the junctions of Euston Street and Stephenson Way.

During phases three and four there will be continued vehicle access from Euston Road. Traffic will leave the local area via Hampstead Road. Stephenson Way will remain accessible from Euston Road.

At each location several parking bays will be suspended. Pavements and pedestrian access will be maintained during the works. Utility supplies and other services will not be affected by these works.
