





Notice of works at the former National **Temperance Hospital site**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. Surveying works from 30 June to 20 July

Before we prepare our site at the former National Temperance Hospital for the station enabling works, we will be carrying out surveying works within the area.

A survey rig will be set up in different locations around the site at ground level. A sensor is carefully inserted into the ground at each position. Data from the sensor is reviewed to ensure that we can safely carry out the site setup.

Enabling works from 14 July to 29 September

So that we have a stable base to carry out construction, we will install a working platform (piling mat) before we begin the main construction works later this year.

The piling mat is made of recycled material (such as cement) which we will lay down and compact.

The material will be transported to the site by road and will be compacted using a roller.

Ten existing steel supports within the site will need to be moved to make way for our future construction works.

We will carry out these activities as quietly as possible and do all we can to reduce the effects of our works on the local area.

Duration of works

Surveying works will take place from 30 June to 20 July

Enabling works will take place from 14 July to 29 September

Working hours

8am to 6pm weekdays (excluding bank holidays)

8am to 1pm Saturdays

We will start-up and close-down activities up to one hour before and up to one hour after normal working hours shown here.

Activities will include deliveries to the entrance on Hampstead Road, unloading, maintenance and general preparation work.

It will not include operation of plant or machinery likely to cause a disturbance

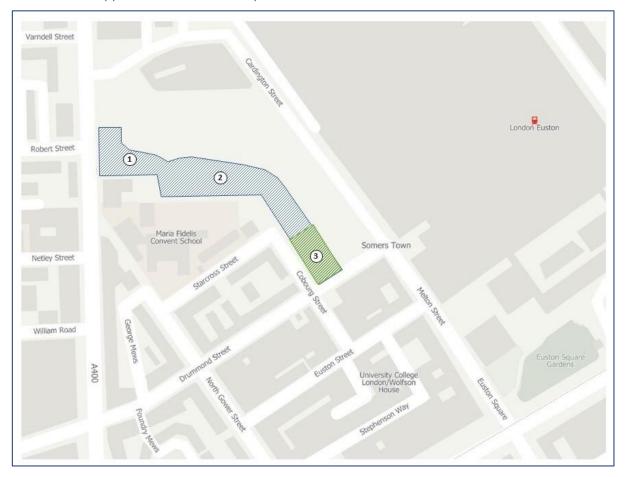

A staff welfare accommodation block will be assembled at the point marked 1 on the plan below in the week beginning 29 June.

It will be located next to the existing block and will be three storeys high (approximately 8m). This additional welfare accommodation block is needed so that our team can maintain social distancing because of COVID-19.

From July to the end of September we will build the piling mat in area 2 on the plan below.

The ten steel supports that need to be repositioned are within area 3.
