## **Update: ongoing works on Adelaide Road**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

## **Update about works on Adelaide Road**

Due to unforeseen circumstances relating to the impact of Covid-19 on our supply chain, temporary lane closures and traffic lights will remain in place on Adelaide Road until September.

Works to install our worksite boundary have also been rescheduled and will now take place from mid-August to late September. You can view the location of our site boundary in our presentation boards available at hs2incamden.co.uk

Once the hoardings are installed, we will reopen Adelaide Road to twoway traffic.

## **Update about works within the Adelaide Road site**

During July and August, we will start carrying out ecological surveys within our site. We will need to remove some low level grasses and bushes to carry out the surveys. We will provide an update before any further vegetation clearance takes place.

From the end of this month, we plan to start works to remove the section of brick wall located within our site boundary.

We understand that the brick wall on Adelaide Road is important to the local community. We need to remove it while we are building the ventilation shaft and head house and will replace it when our works are complete. We're still looking at the design for replacing the wall and will provide more information as soon as we can.
