Update: traffic management and further drainage surveys on Adelaide Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can work within the guidelines are operational. All sites will remain under constant review.

Extension of traffic management until mid-December

We recently wrote to you regarding the traffic management on Adelaide Road, which was due to remain in place until late November. Due to the ongoing impact of COVID-19 on our supply chain, the current temporary traffic lights on Adelaide Road and the closure at the junction of Eton Road will now remain in place until 18 December 2020. We plan to reopen Adelaide Road to two-way traffic from 18 December. We apologise for any further disruption the extended traffic management may cause.

Overnight works to paint road markings

During the week starting 14 December 2020, we plan to repaint the road markings on Adelaide Road. These works will take place overnight from 9pm to 6am. The exact dates for this work remain subject to confirmation and we'll provide updates at HS2incamden.co.uk

The current lane closure and temporary traffic lights will remain in place while we repaint the road markings, but you will be able to use Adelaide Road overnight during these works. Where possible, we will use acoustic sound barriers to minimise the disruption to local residents.

The dates mentioned in this notification may change due to unforeseen circumstances. We will continue to provide updates about our works at **hs2incamden.co.uk**

Duration of works

Traffic management on Adelaide Road extended until 18 December 2020

Utility surveys will take place on 3 December and during the week starting 14 December 2020, we will repaint the road markings. These works will take place overnight between 9pm and 6am

We may be on site for an hour before the start and/or end of shift

What to expect

We plan to reopen Adelaide Road to two-way traffic from 18 December 2020

Short term lane closures and traffic management may be required on Adelaide Road in early 2021 (see page three for more information)

A water tanker will be present during the surveys in case we need to flush the drainage

Measures will be in place to reduce any disruption to residents

Drainage surveys on 3 December

Due to unforeseen circumstances we were unable to carry out planned surveys on 11 November 2020. These surveys have been rescheduled to take place overnight on 3 December 2020 during one night shift from 9pm to 6am to minimise disruption to the road network. We will use a camera to investigate the condition of the drainage and may need to flush the drainage using a high-pressure water jet.

Temporary changes while we carry out the surveys

Lane closures will be in place overnight on Adelaide Road near the junctions with Lower Merton Rise and Elsworthy Rise. Parking bay suspensions will be in place on Adelaide Road and bus stop M (Elsworthy Rise) and U (Primrose Hill Road) will be suspended overnight.

Works planned at Adelaide Road site in early 2021

During early 2021 we will carry out further works to prepare the site for future construction of a ventilation shaft and headhouse. Our works during early 2021 will include:

- Installation of worksite gates
- Construction of a protection slab to form a working platform
- Installation of offices and welfare cabins including utility connections
- Removal of wall foundations

Short-term lane closures and traffic management may be needed during these works. We will provide information about any temporary changes in advance.
