Drainage surveys on Kilburn Priory, Langtry Road and Springfield Lane

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

Additional drainage surveys

We will be carrying out further overnight drainage surveys on Langtry Road and Kilburn Priory on 24 November, Springfield Lane and Kilburn Priory on 25 November, daytime drainage surveys on Springfield Lane on the 28 and 29 November; shown on the maps overleaf. We will investigate the condition of the drainage using a camera and may need to flush the drainage system using a high-pressure water jet. Your utility services will not be affected.

Overnight surveys on 24 November and 25 November

Langtry Road and Kilburn Priory: These works will take place overnight on 24 November between 9pm and 6am. We will temporarily suspend some parking bays on Langtry Road and Kilburn Priory during these works.

Springfield Lane and Kilburn Priory: These works will take place overnight on 25 November between 9pm and 6am. To carry out these works safely, a signed diversion route will be in place to facilitate an overnight road closure on Springfield Lane. To keep vehicle access to and from some of the local businesses, a section of Springfield Lane next to Energie Fitness Gym will be converted to a 2-way system. We will temporarily suspend some parking bays on Springfield Lane during these works.





Kilburn Priory/Langtry Road overnight survey map


