# Drainage surveys on Gloucester Avenue and Princess Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

## Additional drainage surveys

We will be carrying out further drainage surveys on Princess Road and Gloucester Avenue. We will investigate the condition of the drainage using a camera and may need to flush the drainage system using a high-pressure water jet. Your utility services will not be affected.

## Daytime surveys on Princess Road and Gloucester Avenue

On 18 and 19 November we will be carrying out drainage surveys on Princess Road and Gloucester Avenue. These works will take place between 8am and 6pm. Some parking bays on Princess Road and Gloucester Avenue will be suspended while we carry out the surveys.

## Overnight survey on Gloucester Avenue

On 23 November we will be carrying out drainage surveys on Gloucester Avenue. These will take place overnight between 9pm and 6am. Some parking bays on Gloucester Avenue will be suspended while we carry out the surveys.

Maps showing the location of the surveys and temporary parking bay suspensions are included on the next page.

Princess Road and Gloucester Avenue: 18 and 19 November between 8am and 6pm

Gloucester Ave: Overnight on 23 November between 9pm – 6am

Surveying equipment will include a CCTV camera and a water tanker will be present should we need to clear any form of blockage

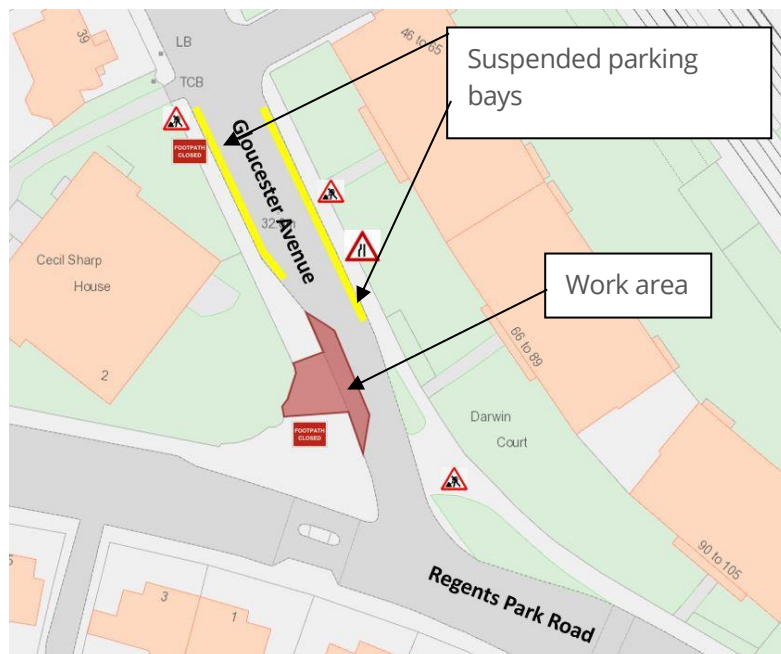
