

# Update on test piling near Granby Terrace bridge

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at [HS2inCamden.co.uk](http://HS2inCamden.co.uk).

We previously informed you we are carrying out test piling near to Granby Terrace bridge. We are using the quietest methods and doing all we can to reduce impacts of our works.

## Test piling ongoing until end August

Test piling continues north of Granby Terrace bridge with testing due to start in late June. A large test rig will be delivered to site and assembled on 23 June. We expect to complete testing in this area by mid-July and will then relocate the piling rig and crane to the test piling location south of the bridge in late July.

Testing of the piles is monitored by computers 24 hours a day, 7 days a week. The monitoring is not noisy and does not need staff to be on site overnight or weekends unless adjustments are needed. A generator will run on a battery at night to reduce noise.

## Notification



### Duration of works

Ongoing to 31 August

Equipment deliveries ongoing

Piling Monday to Friday from 8.00am-6.00pm, with some concrete pours until 8.00pm if needed

Testing requires a generator 24-hours, 7 days a week with acoustic screening (battery-operated at night to reduce noise)

Equipment will be removed from site end of August

### What to expect

Large loads outside peak times via Granby Terrace Bridge where possible

Noise from the piling rig will be a similar level to heavy traffic flow

### What we will do

Construct and test piles in two locations north of Granby Terrace bridge and one south
