Groundwater discharge into Harrington Street manhole

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. High Speed Two (HS2) is the new high speed railway for Britain. Works to set up our main worksite in the Euston approaches continues.

Closure of Harrington Street for groundwater discharge

From 26 October until 31 December, we will need to discharge groundwater from our worksite into the manhole on Harrington Street. From January, we expect to have constructed our permanent drainage connection on Stanhope Street.

We will close off a section of Harrington Street with traffic management to discharge groundwater for a couple of hours each day. The I duration will depend on weather conditions. We will have traffic marshals in place during the closure to ensure safe access at all times. See map below.
