Notification of utility works on Endsleigh Gardens

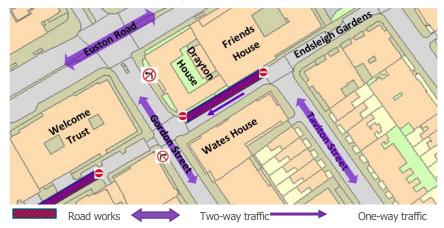
High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

The programme of utility works to the west side of Euston Station includes the laying of electrical power connection ducts and BT telecommunication ducts via North Gower Street across Euston Road, Gower Street and Gower Place finishing at Gordon Street. It also includes laying new Verizon ducts starting at Euston Road, through Gower Place, Endsleigh Gardens and finishing at Upper Woburn Place.

Endsleigh Gardens

From late October works will commence on Endsleigh Gardens between Gordon Street and Taviton Street for four weeks. The works will be carried out on the north side lane and the footpath, parking bays will be suspended, the south side footpath will remain open.



Further works on Endsleigh Gardens will include connection works across Gower Street with the ducts currently being laid down on Gower Place. Verizon will finalise works up to Upper Woburn Place. From 26 October for four weeks between Gordon Street and Taviton Street

Working hours:

Monday to Friday 8am – 6pm,

Saturday 8am – 1pm

What to expect

- Traffic management around work sites and in surrounding roads.
- Loading and parking bay suspensions.
- Pedestrian access will be maintained during the works.
- The initial breaking of the road surface will be the noisiest activity, although this will be intermittent.
- Acoustic panels will be erected to help manage noise.
