Update of utility works on Gower Street and Gower Place

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

The programme of utility works to the west side of Euston Station includes the laying of electrical power connection ducts and BT telecommunication ducts via North Gower Street across Euston Road, Gower Street and Gower Place finishing at Gordon Street. It also includes laying new Verizon ducts starting at Euston Road, through Gower Place, Endsleigh Gardens and finishing at Upper Woburn Place.

Gower Street, Gower Place and Endsleigh Gardens

Further works on Gower Street at the junction with Euston Road have been paused, pending consent from Transport for London and other stakeholders. The road has been re-instated and will re-open from 10 October.

In the meantime, we will restart works on Gower Place, which were paused in the summer to maintain access to the hospital, whilst the works on Gower Street were taking place. Gower Place will now be closed from 12 October for fourteen weeks, subject to the progress of works. We will maintain vehicular access to the Wellcome Trust and UCL buildings only. The footpath will remain open. We will reinstate and temporarily re-open the road during the Christmas shutdown period from 19 December to 3 January 2021.

From late October works will commence on Endsleigh Gardens for four weeks. The works will be completed in phases, parking bays will be suspended in each phase of work, the footpath will remain open. Additional details will be provided in an area specific notification.

- Closed from 12 October for fourteen weeks
- Road will re-open over Christmas from 19 December to 3 January

Endsleigh Gardens:

• From late October for four weeks in phases

Monday to Friday 8am – 6pm,

Saturday 8am – 1pm
