Notice of utility works to the west of Euston Station **September - December 2020**

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites remain under constant review. Euston Street and Regnart Buildings

We are continuing to carry out manhole and sewer relining works in the carriageway of Euston Street until early October.

The road remains closed between Regnart Buildings and North Gower Street. Vehicle access to Regnart Buildings is maintained via Cobourg Street and the refuse collections continue as normal. Access is maintained for emergency vehicles only.

All street loading and parking bays are suspended for the duration of works. You can still use the footpaths on both sides of the road as they will remain open.

We plan to continue manhole construction works in Regnart Buildings and we will need to close the road from early October to February 2021. Refuse collections will continue as normal.

Stephenson Way

A section of the road at the end furthest from North Gower Street is still closed to vehicles. The works to realign the Thames Water main, sewer and gas pipelines and UKPN cables on Stephenson Way were due to finish in October. This has now been extended until February 2021 due to the delays from public utility companies, revised designs, and new safety procedures as a result of COVID-19. The footpath is still open for use.

 Road closed from early October to February 2021

• Until February 2021

North Gower Street

We are laying communication ducts and electrical power connections on **North Gower Street between Stephenson Way and Euston Road until early November**. The road is closed, but you can still use the footpaths on both sides of the road, as they remain open.

As part of these works, we will need to remove the tree at the corner of Euston Road and North Gower street. We have tried to avoid its removal, but unfortunately due to its location and its roots this has not been possible. The timber from this tree will be saved and reused within the local area.

There will be a lane closure on the eastbound Euston Road slip road for one weekend only. Traffic management and diversion signs will be in place.

We are continuing works in the pedestrianised section of North Gower Street between **the junctions of Hampstead Road and Starcross Street until end October**. Residents' access to George Mews and the car park will be maintained during these works.

Euston Road

We are carrying out works on communication ducts connections on the **Euston Road footpath in phases until late October**. Pedestrian access is maintained.

From late October to mid-November we will need to carry out works in the Melton Street northbound lane. The footpath will remain open, access to the taxi rank will be maintained.

From mid-October to mid-November we plan to carry out works in the junction of Euston Road and Gower Street. The slip road access to Gower Street from Euston Road will be closed for the duration of these works with access for emergency vehicles only. Traffic management and diversion signs will be in place.

Gower Street and Gower Place

We are continuing works on the west side lane of Gower Street until mid-October.

Works on Gower Place are currently paused to maintain access to the University College London Hospital until we complete works in Gower Street. Once we re-start, we anticipate it will require ten weeks to complete the works on Gower Place.

At each location of works parking bays will be suspended. Pedestrian access will be maintained. The initial digging of the road will be the noisiest activity, although this will be intermittent and not continuous. We will put up screening clad with acoustic panels to reduce noise. Utility supplies and other services will not be affected by these works.

North Gower Street:

- Ongoing until early November, road is closed between Stephenson Way and Euston Road
- Works in the footpath in the junction with Hampstead Road until end October

Euston Road:

- Works in the northside footpath until late October
- From late October to mid-November works on Melton Street
- Euston Road slipway closure in the junction with Gower Street from mid-October to mid-November

Gower Street:

 Ongoing in west side lane until mid-October

Gower Place:

 Currently on pause until completion of works in Gower Street

What to expect

- Traffic management in place around work sites and in surrounding roads
- Loading and parking bays suspensions
- Pedestrian access will be maintained during the works


