Notice of overnight works between railway tracks and Adelaide Road site

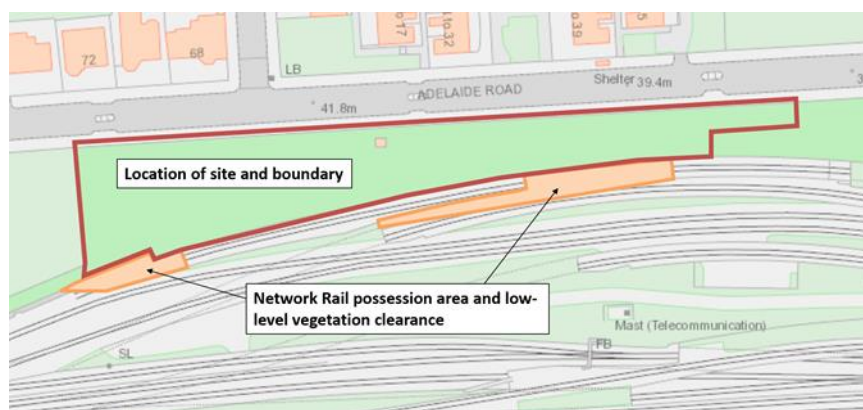
High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review. Works taking place between railway embankment and Adelaide Road site

During September and early October, we will remove shrubs and bushes between our Adelaide Road site and the Network Rail tracks (see the map below showing the area for these works). These works will take place overnight on 19 and 26 September and 3 October during rail track possessions when trains are not using the tracks.

Measures will be in place to reduce any disruption to residents. We will also continue to review our working methods to minimise any disruption. The dates mentioned may change. We will provide updates at HS2inCamden.co.uk
