# Update on works at the vehicle holding area

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on COVID-19. The Government's strategy makes it clear construction can continue as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. All sites will remain under constant review. You can sign up for regular updates in your local area at

#### Vehicle holding area in London Zoo car park

The holding area is for HS2 construction vehicles to wait in until nearby worksites are ready to receive them. This avoids queueing into streets near worksites.

Careful scheduling and logistics planning will ensure as many vehicles as possible travel directly to and from worksites without needing to visit the vehicle holding area.

#### Constructing the vehicle holding area

In January this year we started construction of the vehicle holding area. We will start works again in late May after a pause in line with government and Public Health England advice on COVID-19.

We will remove vegetation to create the access from Prince Albert Road, which will span about a 30m section between the zebra crossing and Gloucester Gate junction, shown in the map on page 2. We will plant grass around the access once it is completed.

Constructing the access from Prince Albert Road and works within car park

Tree removal in late May to make space for access and hedgehog tunnel

Zebra crossing permanently relocated 80m west

#### What we will do

Build a hedgehog tunnel under the new access to create a safe crossing

Plant around 500m of hedges within Regent's Park for hedgehogs

Provide additional nesting boxes and wildlife cameras

In June we will create a tunnel under our access through which hedgehogs can safely cross. We will plant about 500m of hedges and other hedgehog-friendly shrubs in Regent's Park and we are also installing extra nesting boxes, wildlife fencing and cameras. Our video footage of mammal movements is contributing to The Royal Park's research into protecting London's hedgehogs.

Following the access construction, we will carry out a sewer connection from within Prince Albert Road into the vehicle holding area as well as other utilities works. The zebra crossing will be relocated about 80m to the west and we will install traffic lights at the access to the vehicle holding area so vehicles can safely enter and exit the site. These works will impact Prince Albert Road and we will update you when details and dates are confirmed.



#### What happens when the vehicle holding area is operational

There will be green hoarding surrounding the vehicle holding area with a sliding gate, which will remain open during operating hours.

There will be a signalised junction to safely manage vehicles turning into and out of the site and to allow pedestrians to cross. There will be hedgehog-proof fencing either side of the entrance, so hedgehogs are guided into the tunnels beneath for safe crossing.
