Notification

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

High Speed Two (HS2) is the new high speed railway for Britain. We are building a vehicle holding area in the London Zoo car park to hold HS2 lorries so they avoid queueing at nearby worksites whilst making deliveries. The holding area will be operational from April 2021 until HS2 is complete.

Extended footpath closure - Prince Albert Road

We will remove the lane closure on Prince Albert Road on Saturday 28 November, following the completion of utility works. The south side footpath will remain closed whilst we finish construction of the access to the vehicle holding area, shown on the map below. Undertaking this work and extending this footpath closure now means we can avoid closing the footpath again later. We will complete the works on 5 December. We apologise for the ongoing inconvenience.

Recent and upcoming works

We installed a mammal tunnel under the future access so hedgehogs can safely travel along the green verge to the south of Prince Albert Road, avoiding the vehicle holding area. Re-planting of trees and shrubs along the verge will be undertaken in the planting season in early 2021, in line with guidance from The Royal Parks.

Between now and the end of January 2021, we will continue to install reinforced concrete slabs, drainage and ducting. We will also re-install hoarding along our site boundary on Prince Albert Road before the end of December 2020.

We will carry out road marking on Prince Albert Road and within the site in February 2021. TfL will install the traffic lights for the access off Prince Albert Road between February and March 2021. We will update you about these works closer to the time.

Site office - January 2021

We will install the site office from 11 January 2021. Portacabins will be delivered via three large loads, arriving early mornings between 11 and 13 January to avoid peak times.

It will take about a month to install and fit out the building. See map below.
