High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England advice on dealing with COVID-19. The Government's strategy makes it clear construction activity can continue, as long as it complies with this guidance. Please be assured only sites that can operate within the guidelines are operational. You can sign up for regular updates in your local area at HS2inCamden.co.uk.

Temporary traffic management on Prince Albert Road – from 1 March

In March, we will install permanent traffic lights on Prince Albert Road at the vehicle holding area entrance. Until the lights are installed, we need to use temporary traffic management to assist vehicles entering and exiting. This traffic management will be in place from 1 March until the new lights are installed, and will involve a temporary pedestrian diversion and manual traffic management as and when required (see map on next page).

Utility surveys on Parkway – 8 to 9 March and 12 to 13 April

We will carry out CCTV surveys on Parkway to assess the condition of local utilities. Access to the utilities will be via existing manholes. The first survey will be carried out overnight on 8 and 9 March. The second survey will be completed during the day on the 12 and 13 April. These works will involve minimal noise and require traffic management including lane closures as shown on the map on the next page.

Trial holes on Parkway and Albert Street – March to May

We will carry out trial holes within the road on Parkway and Albert Street to inform the design of the upcoming utility diversions. We will provide more detail on diversions ahead of those works.

These trial holes will require lane closures, parking bay suspensions and a traffic diversion on Parkway (see map for details). These works will only begin once the current trial holes on Parkway are complete, to limit the impact on local traffic.

The current works on Parkway have now been revised. The current trial hole will remain until 5 March, and the second trial hole is no longer required (see map on next page for details).

March to May

Core hours: Mondays to Fridays, 8am to 6pm and Saturdays 8am to 1pm, if required

Night works on Parkway from 9pm to 5am on 8 and 9 March

We may be on site for an hour before the start and/or end of each shift

What to expect

Lane and footway closures with pedestrian diversions in place

Parking bay suspension on Parkway

Trial holes within the carriageway on Parkway

New traffic lights on Prince Albert Road

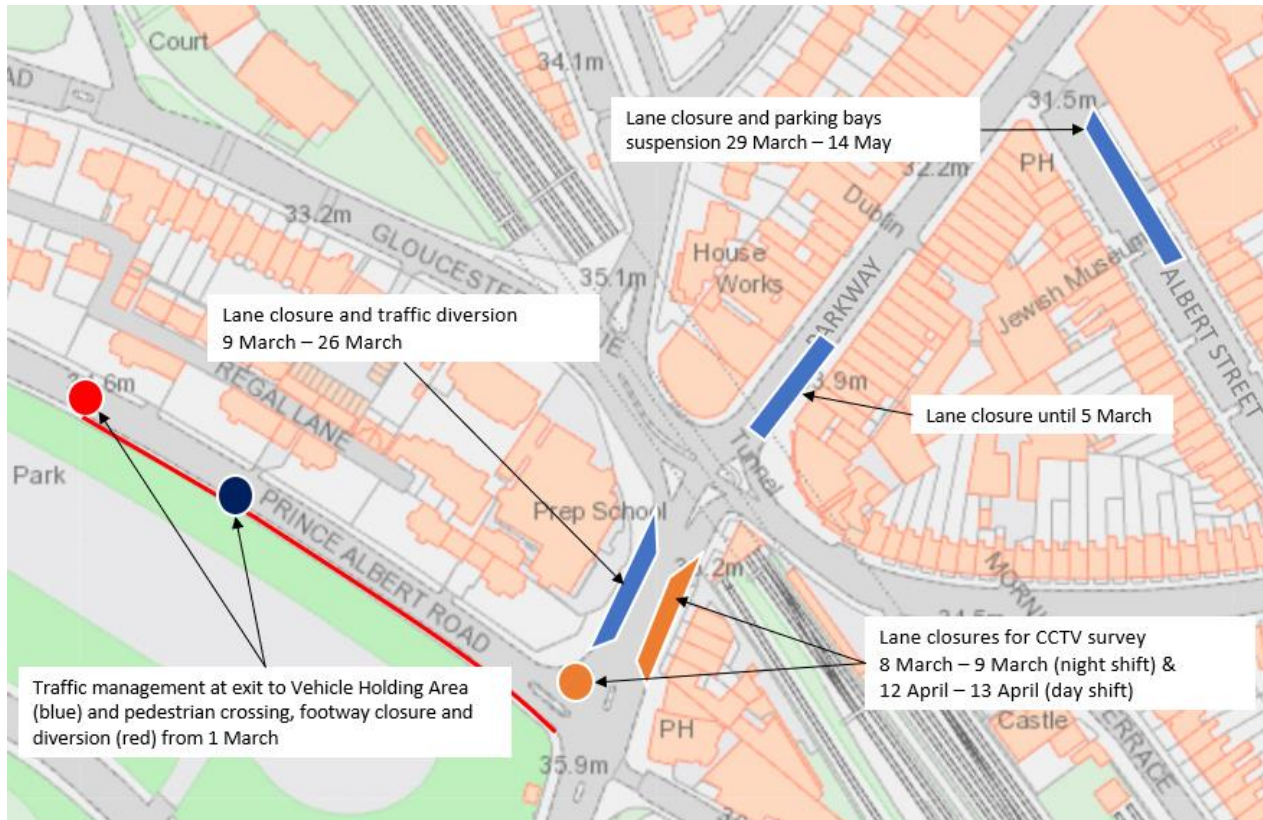
