Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

We will be carrying out ground investigation work in the road along Herlwyn Avenue from 15 June for two weeks. This will involve drilling two bore holes to take core samples of the ground in the areas shown on the map overleaf.

There will be some drilling noise during the day within the hours shown on the panel to the right. Each of the sites will be surrounded by protective barriers and acoustic screens to reduce this noise as much as possible. People will have access to their driveways maintained.

We will begin with the easternmost point first and once that is completed, we will move to the second point. Upon completion of the works we will ensure that the roadway is returned to its original state.

Prior to works starting all operatives on site will be given a site-specific briefing by our Community Engagement Manager.

Duration of works

From 15 June for up to two weeks.

Working hours will be from 8am to 6pm Monday to Friday and 8am to 1pm on Saturday should it be needed.

We may need to be on site up to an hour before/after the end of shift.

What to expect

Sites will be secured with barriers and acoustic screens to reduce noise.

Drilling equipment and mobile units will be on site.

As part of this activity a generator will be needed to run for periods to assist in the work.

What we will do

Access to driveways will be maintained at all time. We will conduct the drilling activity as quickly as we can.
