High Speed Two (HS2) is the new high speed railway for Britain.

#### **Being COVID-19 Compliant**

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. #### What we are doing

From 28 September we will carry out utility surveys along Bridgwater Road, shown on the map overleaf. The surveys will help us understand the condition and location of the utility services and help us decide how best to protect them while we are building HS2.

The surveys will take place during the day. We will investigate the condition of the sewer system using a small CCTV camera mounted on a small robot. Should we find a blockage we may need to flush the drainage system using a high-pressure water jet to carry out the investigation.

#### How the surveys might affect you

Due to the location of the utility surveys below the road, temporary traffic management and parking bay suspensions will be in place.

Should vehicles not abide by the parking bay suspensions, we will reposition them further up the road where necessary. This is to ensure the surveys can be carried out safely with the traffic flow controlled.

The surveys will take place from 28-30 September.

Hours worked will be Monday to Wednesday 8am to 6pm.

We may be on site for an hour before the start and/or end of each shift.

#### What to expect

Temporary traffic management and parking bay suspensions will be in place, with vehicles repositioned if necessary.

Surveying equipment will include a CCTV camera and a water tanker will be present should we need to clear any form of sewer blockage.

We will provide access to your property at all times.


