Notice of utility surveys in the South Ruislip area

High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

On 24 September we will carry out utility surveys along Long Drive, opposite the Sainsbury's store before the intersection with Victoria Road shown on the map overleaf. The surveys will help us understand the condition and location of the utility services and help us decide how best to protect them while we are building HS2.

The surveys will take place overnight. We will use scanning equipment to create a map of the utility services below ground and they will be marked using biodegradable spray paint. Once the survey of the site is complete, photos of the paint marks will be taken to record the location of the utilities.

How the surveys might affect you

Due to the location of the utility surveys below the road, temporary traffic management will be in place overnight. This is to ensure the surveys can be carried out safely.

Duration of works

On 24 September we will be carrying out surveys on the area shown on the map overleaf.

The surveys will take place overnight between the hours of 8pm to 6am. We may be on site for an hour before the start and/or end of each shift.

What to expect

Temporary traffic management and parking bay suspensions will be in place.

Surveying equipment including tripods and trolley mounted.

Our works will cause minimal noise disruption and your utility services will not be affected.

What we will do

We will provide access to your property at all times.

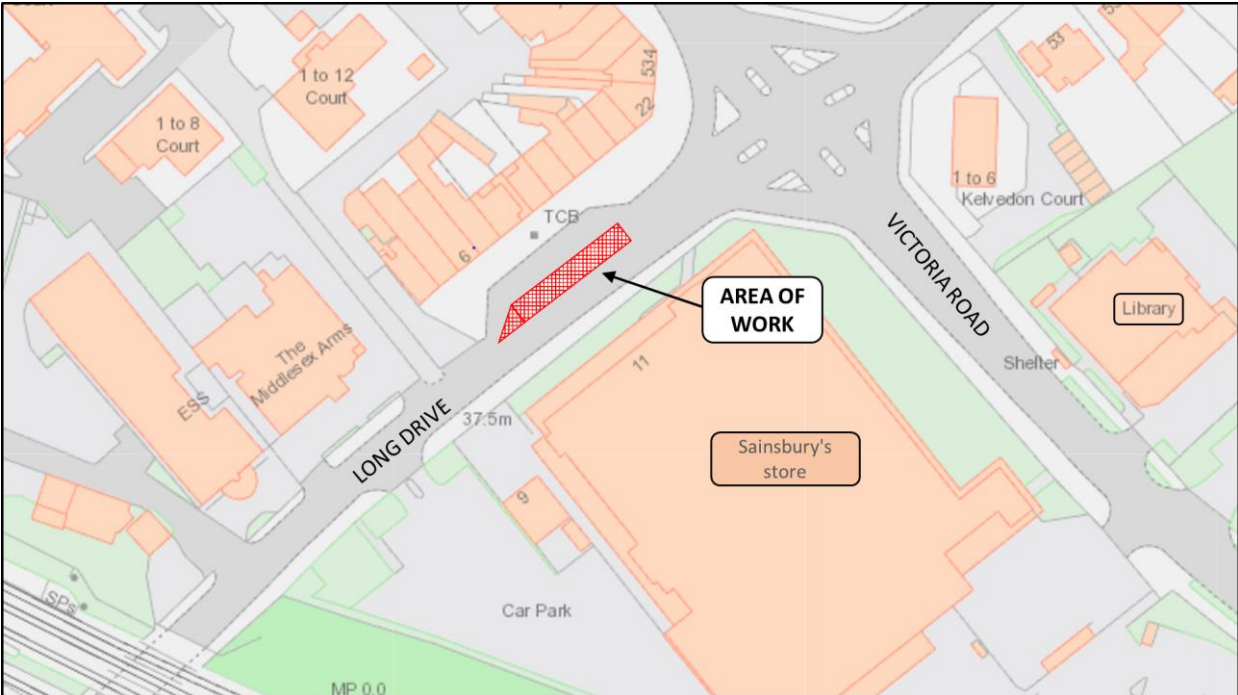
