#### **Being COVID-19 Compliant**

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. #### What we are doing

On 23 September we will carry out further utility surveys along West End Road near Sidmouth Drive. The surveys will help us understand the condition and location of the utility services and help us decide how best to protect them while we are building HS2.

The surveys will take place overnight. We will use scanning equipment to create a map of the utility services below ground and they will be marked using biodegradable spray paint. Once the survey of the site is complete, photos of the paint marks will be taken to record the location of the utilities.

#### How the surveys might affect you

Due to the location of the utility surveys below the road, temporary traffic management and parking bay suspensions will be in place overnight. This is to ensure the surveys can be carried out safely.
