High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

We will be carrying out ground penetrating radar surveys on the footways of Ickenham High Road from 23-25 September.

First, we will put small paint studs on the ground to set up the survey area. Scanning equipment will then be used to create a map of the utility services below ground and they will be marked using biodegradable spray paint. We will use cameras to take site photos of the completed works.

The location of the activity is shown on the map overleaf.

These surveys are very short in duration. We will not be closing the footways, but you may be asked to wait for a short period whilst we conduct a survey.

The activity will take place from 23-25 September

Hours worked will be Wednesday to Friday 8am to 6pm

We may be on site for an hour before the start and/or end of each shift

Surveying equipment including tripods and trolley mounted or vehicle mounted equipment

Temporary traffic management will be in place

Temporary markings on the road and footway are harmless to the environment and will wash away

What we will do

Provide access to local residences and businesses at all time
