# Notice of utilities work at Bridgwater Road

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

## What we are doing

From 22 February 2021, we will be carrying out ground and sewer system investigation along Bridgwater Road, in the area shown on the map overleaf. This will help to inform our design decisions in the area.

The ground investigation will involve the use of scanning equipment to identify the utilities in the area. We will be excavating trial holes to take measurements and ground samples.

To investigate the condition of the sewer system and the manholes, we will be using a CCTV camera mounted on a small robot. Should we find a blockage we may need to flush the drainage system using a high-pressure water jet in order to carry out the investigation.

## How the surveys might affect you

Due to the location of the utility surveys below the road, temporary traffic management will be in place. This is to ensure the surveys can be carried out safely.

There will be no disruption to your utility services.

## Duration of works

The activity will take place from **22 February to 8 March 2021**

The surveys will take place from **8am to 6pm** Monday to Friday and **8am to 1pm** on Saturdays

We may be on site for an hour before the start and/or end of each shift

## What to expect

There will be up to eight operatives in the work area, as well as excavation equipment to take samples and measurements, and surveying equipment, including a CCTV camera

## What we will do

Hoarding and noise reducing screens will be used to lower the volume of the works

Use water carts to keep dust to a minimum

We will maintain access to your property at all times

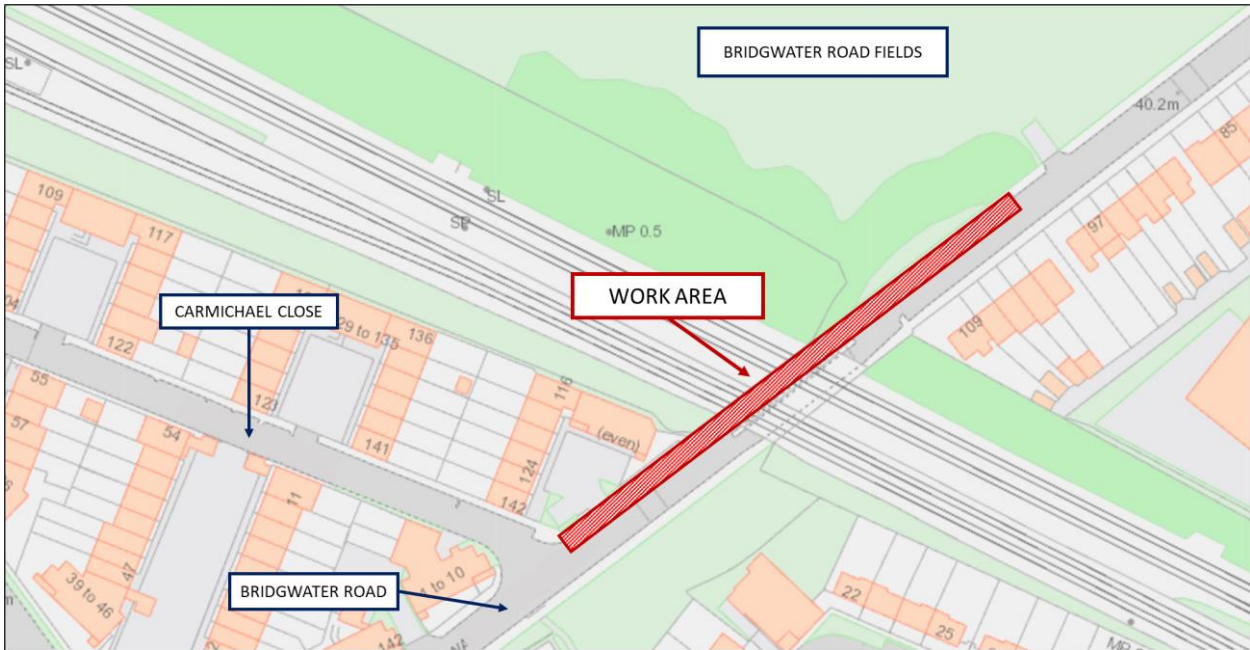
