Notice of works at Newyears Green Lane

High Speed Two (HS2) is the new high speed railway for Britain.

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within these guidelines are operational. All sites will remain under constant review.

What we are doing

During the week commencing 15 March 2021, we will be carrying out works along Newyears Green Lane, shown on the map overleaf:

- vegetation clearance. This activity will need to be carried out under a road closure, between 8am and 6pm. At the end of each shift we will restore the area to its previous condition.
- utility surveys to investigate the condition of the culvert system, using a small CCTV camera mounted on a small robot. If a blockage is found, we may need to flush the system using a high-pressure water jet in order to complete the investigation. This activity will be completed in one day if the weather permits.

Due to the location of these works, temporary traffic management will be required to ensure the surveys can be carried out safely.

Access to the BFA Recycling Centre will be maintained throughout the works.

The work will take place from the 15 March to the 19 March, between 8am and 6pm

We may be on site for an hour before the start and/or end of each shift

Temporary traffic management

The use of equipment, including strimmers, to remove vegetation

Surveying equipment including a CCTV camera, and a water tanker should we need to clear a blockage

What we will do

Maintain access to your property at all times and keep the area tidy
