High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

We will be carrying out an upgrade to the footpath that runs alongside the River Pinn, under the Chiltern Line rail bridge and then eastwards towards Hoylake Crescent.

To improve the current condition of the footpath we will scrape away the existing topsoil and level the ground. We will then place suitable material onto the path and roller to create a level surface.

The footpaths shown on the map will remain open however we will need to complete the work in stages, closing half of the footpath at a time.

Duration of works

The works will begin from 1 February 2021 for two weeks.

The hours of work will be 8am to 6pm Monday to Friday and 8am to 1pm on Saturday if required

What to expect

We will be using a small excavator to remove the topsoil and a small dumper truck to transfer it from site. We will use a small drum roller and compacting plate to level and secure the footpath materials

What we will do

The footpath will remain open, but to carry out the work it will be reduced in width. We will upgrade one half of the footpath and then move our work to the other side
