High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What are we doing?

We will be installing track monitoring sensors along the railway from West Ruislip to Harvil Road, shown on the map overleaf. This system will be in place to monitor settlement and twists in the railway tracks for the duration of the project. The equipment is self-powered, so no wires or cables will be required.

For the safety of operatives and rail users, the work will take place during a period where the Chiltern Line has no trains on the tracks for the safety of the operatives and rail users. We will be using hand tools so the noise from the works will be minimal.
