Being COVID Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

From 15 December we are carrying out night works at South Ruislip Vent Shaft, shown on the map overleaf.

We will carry out some investigations on the cabling that runs along the boundary of our site, between Ruislip Gardens and South Ruislip stations. We will also use an excavator to remove an existing lighting pole at track level between our site compound and the railway.

The work will take place at night during a track closure for safety.

How this may affect you

You may see people and equipment operating on site and along the railway. Noise and dust reduction measures will be in place to minimise disruption.

These works will not affect your electricity supply.

These works will take place from **15 to 18 December**.

Working hours are between **00.45am** and **07.40am**.

We may be on site for an hour before the start and/or end of each shift.

Excavation equipment and people walking along the railway.

What we will do

Any lights needed for this work will face away from residences.

Keep disruption from dust and noise to a minimum.

Ensure there is no interruption to your utility services

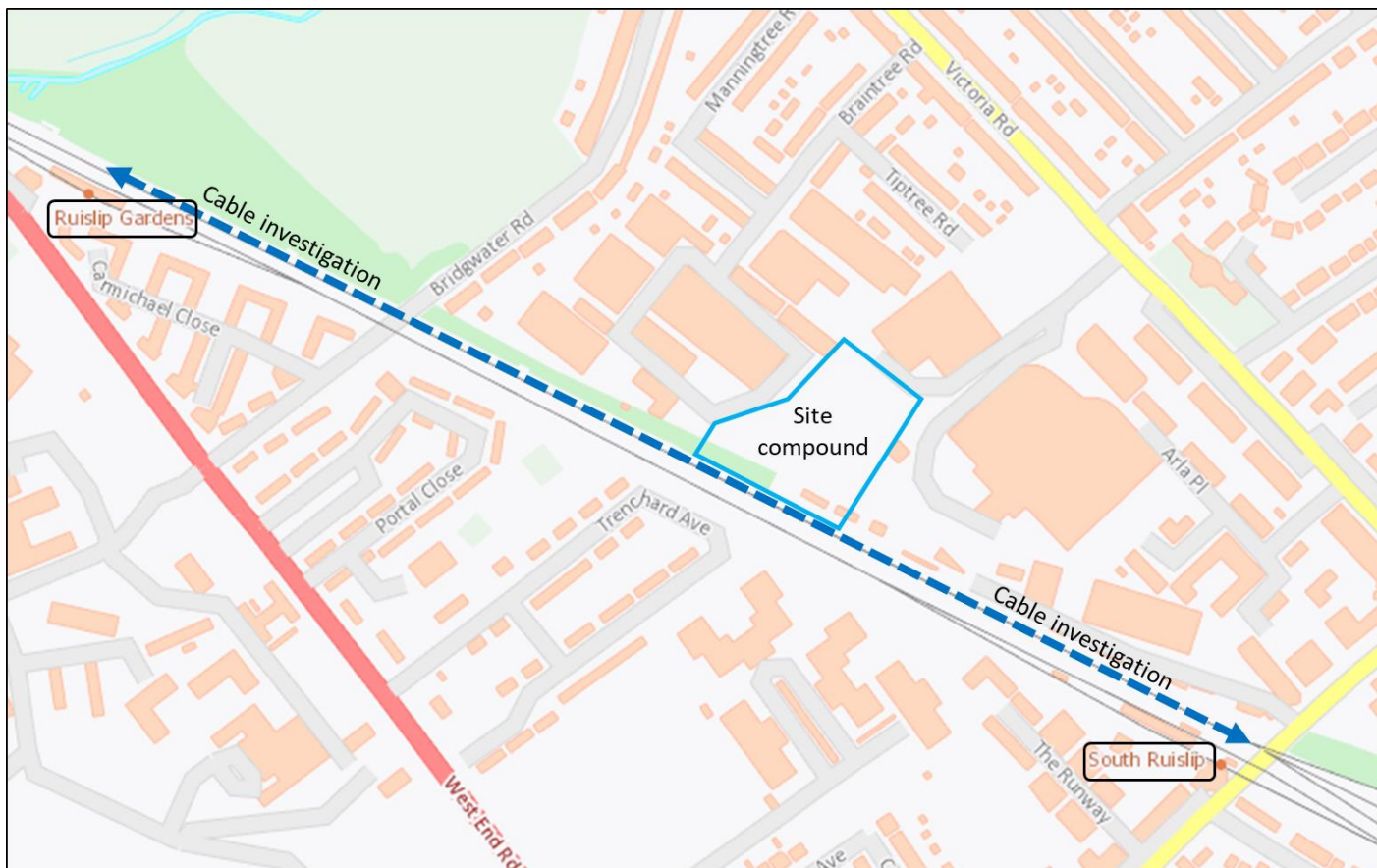
