High Speed Two (HS2) is the new high speed railway for Britain.

Being COVID-19 Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. What we are doing

From 26 January to 29 January 2021, we will be carrying out works along the rail track at South Ruislip Vent Shaft, shown on the map overleaf.

We will carry out investigation on the cabling that runs along the boundary of our site and we will install fencing to protect the rail tracks in the area.

The work will take place at night during a rail possession for the safety of the operatives and rail users.

How this work might affect you

You may see people operating on site and along the railway. We will only be using hand tools so the noise from the works will be minimal.
