High Speed Two (HS2) is the new high speed railway for Britain.

## Being COVID Compliant

We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites. ## What we are doing

We are connecting a temporary water supply from the water main in Breakspear Road South that will provide the water supply for the construction activities and welfare units at West Ruislip.

To carry out this work, Affinity Water and their primary contractor Barhale will create a spur from the 18-inch main and run it into the works compound (shown on the maps overleaf). During the creation of the initial spur we will need a southbound lane closure to protect the operatives. This lane closure will be controlled by traffic signals.

## How the work might affect you

Commissioning of the water supply will be done under the authority of Affinity Water.

These works and the subsequent use of the water will not affect your domestic supply.

These works will take place over seven consecutive days beginning on the 23 November

Work will take place between 8am and 6pm Monday to Friday, and 8am to 1pm on Saturday

Temporary traffic management and the southbound lane closure on Breakspear Road South controlled by automated signals and supervised by staff during the busier periods

Ensure no interruption to your water supply
