High Speed Two (HS2) is the new high speed railway for Britain.

Rescheduling of works on Breakspear Road South

The planned lane closure on Breakspear Road South we told you about last week has had to be postponed.

We will be rescheduling these works for later this week, Thursday 20 February to Saturday 22 February.

Please accept our apologies for any disruption these changes have caused. We are providing shorter notice than usual as there is an opportunity to undertake this work during the school half term period, which will hopefully lessen the disruption the lane-closure may cause.

Works on Breakspear Road South

From **20 February** work will begin on the removal of a temporary access and to reinstate it back to its former entrance.

The work will involve breaking up and removing the concrete access way, and the removal of temporary pipes. The existing ditch will be cleaned and prepared to maintain the ditch drainage system that is in place. Once the drainage work is complete the new entrance can be constructed.

Most of the work will be carried out from within the site with only the work adjoining Breakspear Road South having to be undertaken from the roadside. When working on the section of the entrance next to the road, two-way temporary traffic signals will be in place to control traffic and give protection to the workforce.

Once this is completed a new vehicle gate will be put in alongside a new pedestrian kissing gate, and new fencing will also be installed to complete the works and keep the field secure.

This work will be completed on the 22 February 2020.

Duration of works

From Thursday 20 February 2020 for three days

Working hours are 8am to 6pm

Barhale may also be on site for one hour's start-up and shutdown

What to expect

A temporary lane closure with traffic management on Breakspear Road South during the half term

Signage will be in place 24 hours a day
