Notice of weekend road closure on Harvil Road

High Speed Two (HS2) is the new high speed railway for Britain. As part of the railway's construction we are continuing preparatory works within Hillingdon.

Hoarding installation and vegetation clearance

We have rescheduled the hoarding installation works we originally informed you about at the end of July 2019. The work is now scheduled to take place from 17 January to 20 January 2020 where we will install solid hoarding along our site on Harvil Road.

We will remove a section of the existing metal fencing to the south of the Chiltern railway bridge and replace it with a solid white hoarding.

We need to remove some vegetation and trees along the verge in order to access the fencing to replace it. We will also be clearing all vegetation and trees between the section of Harvil Road south of the railway bridge and the Chiltern line railway as preparation for works to build a new section of Harvil Road.

Weekend road closure on Harvil Road

A temporary road closure will be in place whilst we carry out this work. A section of Harvil Road will close at 7pm on Friday 17 January and reopen at 6am on Monday 20 January. Please see the map overleaf for the exact location. We will be working throughout the closure including at night to reduce the disruption to the local community and road users.

We must ensure the safety of the public and of our workforce, so we are unable to carry out this work without a road closure. The majority of work will be undertaken overnight and at weekends in order to reduce the disruption to the local community and road users.

We encourage drivers to follow the advised diversion route (please see map overleaf). In case of any changes to these dates, updates will be available on hs2inHillingdon.co.uk where you can sign up for news.
