Update on pipeline diversion works near Harvil Road, Harefield

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

We have postponed all face-to-face engagement events and meetings and have put in place a number of channels to communicate with communities, such as letters and phone calls, as well as updates and alerts from each of the local community websites.

Cadent is carrying out work to complete a gas pipe diversion it started in the area last year. We expect the work to be completed by October 2020

What are we doing?

We will be working on land either side of Harvil Road, north of the Chiltern Mainline while we carry out the rest of the diversion. This will involve:

- setting up a small compound within our existing working area off Harvil Road
- installing the new pipe underneath Harvil Road
- connecting and testing the new pipeline.

We will be accessing our working area using existing HS2 site entrances off Harvil Road.

There will be 24-hour security on site so we can maintain a safe working environment. Please note, there will be no on-site lodging.

Duration of work

- June – October 2020
- Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat) (excluding testing works)
- We will be on-site one hour either side of these times for set-up and close-down

What to expect

- Use of existing site accesses and our former construction compound as our main site
- 24-hour security on site.
- No disruption to your utilities

What we will do

- Inform you as our work progresses
- Keep disruption from construction traffic to a minimum

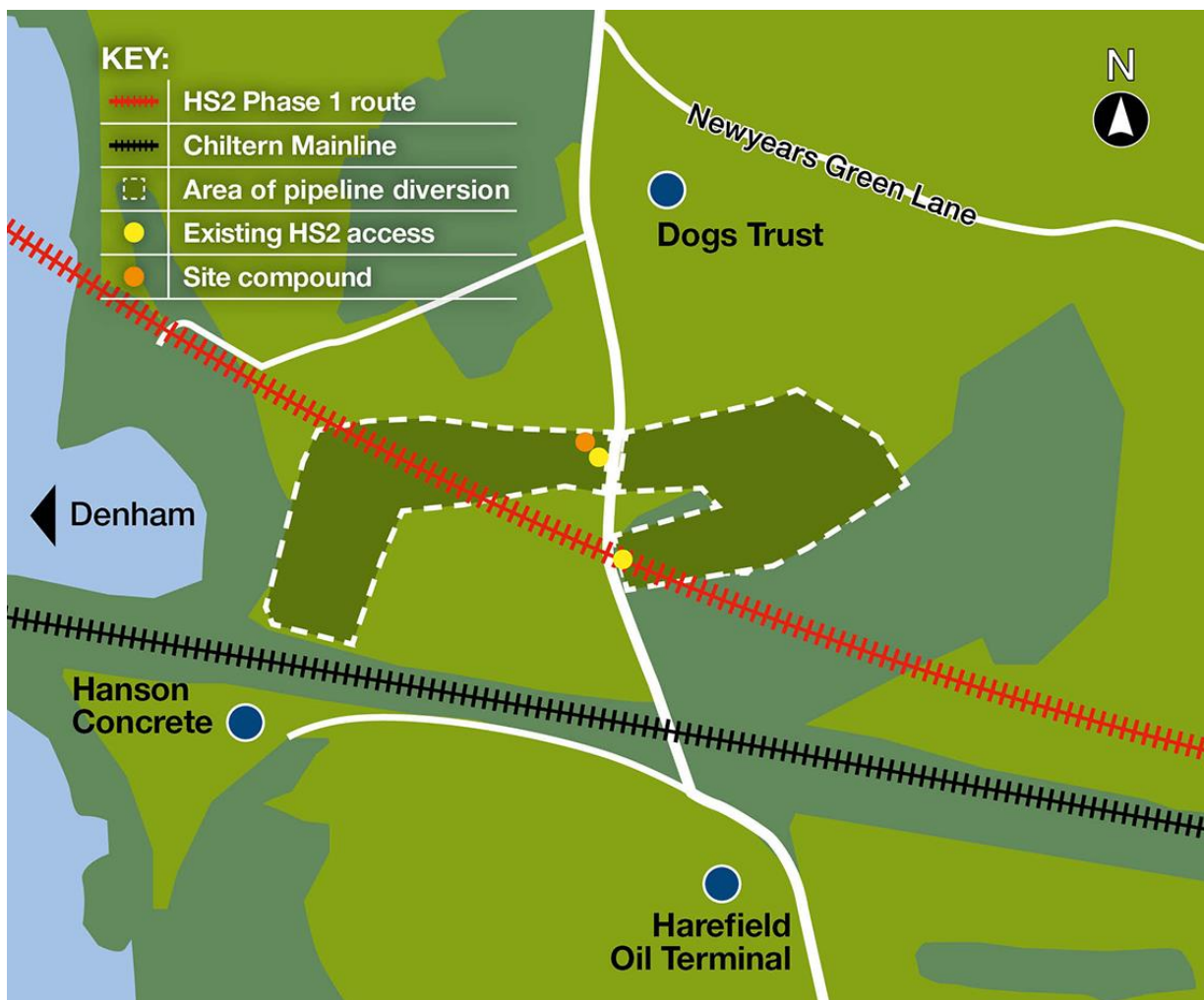
How will this affect you?

Most of our work will take place during usual HS2 working hours of 8am to 6pm Monday to Friday and 8am to 1pm on Saturdays.

Testing on the new pipe will take place outside of standard working hours so you may see people and equipment on site in the evenings. This will only be occasional, and noise will be low-level.

There shouldn't be any disruption to your utilities during our works.
