

Update on gas pipeline diversion works near Harvil Road, Harefield

Notification



High Speed Two (HS2) is the new high speed railway for Britain. The Government's current strategy sets out that during the COVID-19 outbreak construction activity should continue, as long as work can comply with Government and Public Health England guidance.

We will be keeping our local website, www.hs2inhillindon.co.uk up to date with information on our works, and the measures we have in place to maintain the safety of the community and our workforce.

Following a winter shutdown period, Cadent is returning to its former compound off Harvil Road to complete work on the gas main diversion that it started last year. We expect work to be completed by June 2020

What are we doing?

We'll be reinstating land in our former working area north of the Chiltern Mainline off Harvil Road. We will be using our existing compound off Harvil Road, north of the Chiltern Mainline and existing site accesses.

There will be 24-hour security on site so we can maintain a safe working environment. Please note, there will be no on-site lodging.

How will this affect you?

Our work will take place during usual HS2 working hours, which are listed in the box to the right of this page. We will keep disruption to a minimum.

There shouldn't be any disruption to your utilities during our works.

Duration of work

- Mid-April to June 2020
- Our working hours will be 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat).
- We will be on-site one hour either side of these times for set-up and close-down

What to expect

- We will maintain a safe working environment.
- Use of existing site accesses and our existing compound as our main site.
- 24-hour security on site.
- No disruption to your utilities.

What we will do

- Inform you as our work progresses.
- Keep disruption from construction traffic to a minimum.
