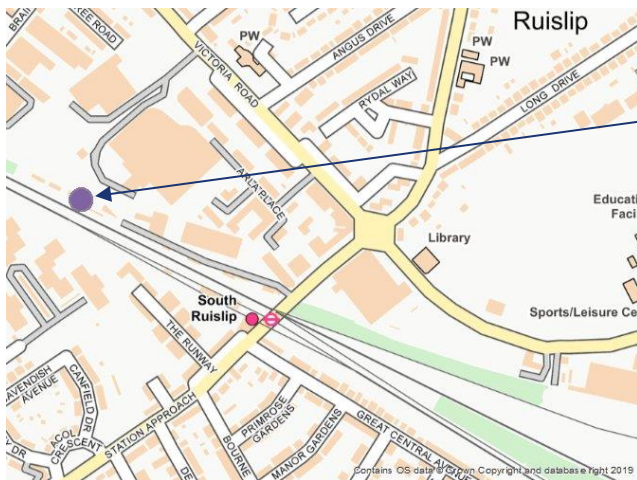
# Ground Investigations in Asda Car Park

High Speed Two (HS2) is the new high speed railway for Britain. As part of developing the route design of the HS2 high-speed railway, we are carrying out further ground investigation surveys in your area. The results will build on the information we already have from work done in 2017, helping us get a better understanding of the ground conditions and underground building foundations.

## What are we doing?

We will be carrying out ground investigations work next to the railway line in the Overflow Car Park of Asda Supermarket, South Ruislip from 22 November for up to four weeks. This involves drilling down to retrieve a small core of the ground. To do this we use drilling rigs which are small enough to be towed by an off-road vehicle. The approximate location of the survey is shown below.

There will be some noise during the daylight hours listed in the panel to the right; the site will be surrounded by protective barriers and acoustic screens to reduce this. We will position the working area into the smallest area possible. We will attempt to avoid the main Saturday shopping day. These dates may change due to unforeseen circumstances. We will keep you informed about any changes.

## Duration of works

From week beginning 22 November for up to four weeks

Working hours are from 8am to 6pm, Mondays to Fridays, and 8am to 1pm Saturdays if needed

We may be on site for an hour before the start and/or end of each shift

Sites secured with barriers and acoustic screens to reduce noise

Drilling equipment and mobile units on site

As part of testing activity a generator might need to run for periods during these works
