

Notice of Ground and Lake Investigation works - Harefield

High Speed Two (HS2) is the new high speed railway for Britain. We are continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review.

Ground Investigations (GI)

Ground investigation surveys give us more information about the type, strength and details of the land where the new railway will be built. To understand the ground conditions beneath the viaduct we need to drill small holes into the ground to extract samples for testing.

We use drilling rigs which are small enough to be towed by a typical off- road vehicle. Some of these works will be taking place on sites using existing access routes off Moorhall Road, Harvil Road and Dews Lane. Some locations in Korda Lake and in Savay Lake will be conducted from floating pontoons. During these lake works we will be working extended hours, Monday to Sunday 7am-7pm.

In some circumstances, where access is not possible through any other means, we may need to remove some surrounding vegetation for these works, so we can gain access to the site. Our ecologists will inspect these areas prior to works taking place.


How will this affect me?

If you live near to one of the GI sites, you may become aware of a small team of operators working the machinery, and you may hear some drilling noise and general site activity during working hours whilst the investigations are taking place. However, this will be kept to a minimum as much as possible.

Any Public Rights of Way will be maintained wherever possible, however whilst works are taking place access will be managed by on site staff with signage and traffic marshalling for pedestrians.

We will also be carrying out some Geophysics surveys in land east of Harvil Road location of the Colne Valley Viaduct south embankment on Sunday 20 September 8 – 6pm. These works are not intrusive and are subject to the necessary approvals.
